15	WHEREAS, The Mental Health Plan was established pursuant to Welfare and	
16	Institutions (W&I) Code, Section14726 through 14712, direct the California Department of	
17	Health Care Services to implement and administer Managed Mental Health Care for Medi-Ca	
18	eligible residents of this state through contracts with mental health plans; and	
19	WHEREAS, The Mental Health Services Fund was established pursuant to Welfare	
20	and Institutions (W&I) Code, Section 5890, and provides funds to counties for the	
21	implementation of its MHSA programs for prevention and early intervention, community	
22	services and supports, workforce development and training, innovation, plus capital facilities	
23	and technological needs; and	
24	WHEREAS, Pursuant to United State Code, Title 42, Sections 290cc-21 through	
25	290cc-35, the PATH grant funds community based outreach, mental health and substance	

1	abuse referral/treatment, case management and other support services, as well as a limited
2	set of housing services for the homeless mentally ill; and
3	WHEREAS, DHCS awards federal Community Mental Health Block Grant funds
4	(MHBG) to counties in California to provide services to the following target populations:
5	children and youth with serious emotional disturbances, adults and older adults with serious
6	mental illnesses; and
7	WHEREAS, The County's performance contract, a copy of which is on file with the
8	Clerk of the Board of Supervisors in File No. <u>140056</u> , as required by Welfare and Institutions
9	Code, Sections 5650(a), 5847, and Title 9, California Code of Regulations (CCR), Section
10	3310, sets forth conditions and requirements that County must meet in order to receive this
11	funding; and
12	WHEREAS, The Director of Community Behavioral Health Services is designated to
13	sign this Agreement and any and all amendments in the future including increases to add
14	other components on behalf of the Department of Public Health (DPH); now, therefore, be it
15	RESOLVED, That DPH is hereby retroactively authorized to enter into a performance
16	contract agreement with DHCS; and, be it
17	FURTHER RESOLVED, That the Board of Supervisors hereby designates the Director
18	of CBHS to sign said agreement on behalf of DPH; and, be it
19	FURTHER RESOLVED, That the Director of Community Behavioral Health Services is
20	designated to sign any and all amendments to this agreement; and, be it
21	FURTHER RESOLVED, That within thirty (30) days of the performance contract being
22	fully executed by all parties the Director of Community Behavioral Health Services shall
23	provide the performance contract to the Clerk of the Board for inclusion into the official file.
