3 **Resolution establishing the Appropriations Limit for Fiscal Year 2001-02 pursuant to**
4 **California Constitution Article XIII B.**

7 WHEREAS, Article XIII B of the California Constitution provides that the annual
8 appropriations of the City and County of San Francisco which are subject to said Article may
9 not exceed the Appropriations Limit for the prior year, with adjustments as provided in said
10 Article XIII B; and

11 WHEREAS, The California Government Code, Sections 7901-7914, defines the terms
12 and sets forth the equations to be used to determine San Francisco's annual appropriations
13 limit; and

15 WHEREAS, The resulting calculation establishing San Francisco's 2001-02
16 Appropriations Limit is:

$$\$ 1,569,917,337 \times 1.078200 \times 1.014400 = \$ 1,717,059,535; \text{ and}$$

18 WHEREAS, For future Appropriations Limit calculations pursuant to said Article, the
19 City will use the gross appropriations limit of \$1,717,059,535; and

21 WHEREAS, This matter has been considered at a regularly scheduled meeting of the
22 Board of Supervisors for the City and County of San Francisco; and



24 WHEREAS, The documentation used to determine the Appropriations Limit for the City
25 and County of San Francisco for fiscal year 2001-02 was available for public inspection in the

1 office of the Clerk of the Board of Supervisors for at least fifteen (15) days prior to said
2 regularly scheduled meeting; now, therefore, be it

3 RESOLVED, That the City and County of San Francisco elects to use the percentage
4 change in California per capita personal income from the previous year as the measure of
5 "change in the cost of living" for purposes of computation of its Appropriations Limit pursuant
6 to Article XIII B of the California Constitution for fiscal year 2001-02; and, be it

8 FURTHER RESOLVED, That the net appropriations limit for fiscal year 2001-02 is
9 established at \$1,717,059,535.
