6 WHEREAS, The Ocean View, Merced Heights, Ingleside Neighbors in Action (OMI-  
7 NIA) is a group of neighbors organized to address issues of common concern to the Ocean  
8 View, Merced Heights, and Ingleside (OMI) communities; and

9 WHEREAS, OMI-NIA has the purpose of informing, unifying, and organizing the  
10 community to improve the public safety and environmental aspects of life in these  
11 neighborhoods and works to make the OMI streets, parks, schools, and public places safe  
12 and attractive; and

13 WHEREAS, The OMI-NIA was established to make Ocean View Park/Minnie and Lovie  
14 Ward Recreation Center and the Broad-Randolph corridor safe and drug free places, with a  
15 wide range of high quality activities that appeal to residents of all ages; and

16 WHEREAS, The OMI-NIA sponsors the annual Christmas Party and toy giveaway at  
17 the Ocean View Park/Minnie and Lovie Ward Recreation Center, and supports annual events  
18 such as the Lunar New Year Celebration, Easter Egg Hunt, OMI United Festival, Backpack  
19 Giveaway, and Kwanzaa Celebration among others; and

20 WHEREAS, In addition to advocacy for Ocean View Park/Minnie and Lovie Ward  
21 Recreation Center, OMI-NIA has played a significant role in other neighborhood improvement  
22 efforts, such as the rebuilding of Sheridan Elementary School, the new Ocean View and  
23 Ingleside branch libraries, the OMI Family Resource Center, the OMI-Excelsior Beacon  
24 Center, and the Geneva Car Barn's Powerhouse Arts Project; and

25 WHEREAS, In 2013, OMI-NIA marks its 25<sup>th</sup> Anniversary as a nonprofit serving the

1 Ocean View, Merced Heights, and Ingleside neighborhoods; now, therefore, be it

2 RESOLVED, That the Board of Supervisors hereby declares October 24, 2013, as

3 Ocean View, Merced Heights, Ingleside Neighbors in Action Day in the City and County of

4 San Francisco.


