14 WHEREAS, Alpha Kappa Alpha Sorority has chosen San Francisco for its 65th
15 Biennial International Conference held on July 20-27, 2012 and has recognized this City as a
16 "Golden Gateway to External Service," using San Francisco as a backdrop as they challenge
17 their members to rise to new levels of leadership and service; now, therefore be it

18 RESOLVED, That the Board of Supervisors recognize Alpha Kappa Alpha Sorority's
