9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Jose Parra v. City and County of San  
12 Francisco, et al., San Francisco Superior Court, Case No. CGC-20-582468 by the payment of  
13 \$115,000. The lawsuit involves alleged personal injury on a City walkway.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 January 27, 2020, and the following parties were named in the lawsuit: Plaintiff Jose Parra;  
16 Defendant City and County of San Francisco.
