3 REGARDING PARKING REGULATIONS ON A PORTION OF TURK STREET.

6 Be it ordained by the people of the City and County of San Francisco:

7 Section 1. Article 3 of the San Francisco Traffic Code is hereby amended by
8 amending Section 32.6.24 thereof to read as follows:


9 **SEC. 32.6.24. PARKING CONTROL, PORTION OF TURK STREET; PENALTIES**

10 **FOR VIOLATION.** No person shall stop, park, or leave standing any vehicle, whether
11 attended or unattended, on either the north or south side of Turk Street, from ((145 feet))
12 Laguna Street to 435 feet easterly (435-foot zones) ((east of Laguna Street (290-foot
13 zone))), except official City-owned vehicles displaying a valid permit issued by the
14 Emergency Communications Department authorizing parking in such zones. The permit
15 exceptions under this Section shall not apply when parking prohibition regulations for
16 street-cleaning purposes are in effect. Violation of this Section is an obstruction to the free
17 use of property and a nuisance within the meaning of Division 4, Part III of the Civil Code
18 of California relating to nuisance and the abatement thereof.


