11	Section 1. Findings.		
12	(a) Pursuant to Ordinance No. 391-81 and DPW Order No. 171, 475, the Department		
13	of Public Works issued revocable permission to Gilbert Ray Herrera and Raymond Al Herrera		
14	to occupy the street flower market location on the south side of Market Street within 100 feet		
15	of the west line of 5 th Street. Copies of said documents are in Clerk of the Board of		
16	Supervisors File No		
17	(b) As set forth in DPW Order No. 173,304, a copy of which is in Clerk of the Board of		
18	Supervisors File No, the Herreras have agreed to convey the subject flower		
19	market permit to the fronting property owner, The Lurie Company, and request permission		
20	from this Board to do so in accordance with Public Works Code Section 161(I).		
21	(c) If this Board approves the sale of the permit to The Lurie Company, said company		
22	has requested that this Board delete this street flower market location from the list of market		
23	locations authorized under Public Works Code Article 5, Section 155. Such request is in Cler		
24	of the Board of Supervisors File No

1	(d) As stated in DPW Order No. 173,304, which is incorporated herein by reference,		
2	the Department of Public Works had not made a recommendation on the sale of the street		
3	flower market permit and the subsequent deletion of this site from the list of stand locations		
4	because it believes that this is a policy matter for this Board to consider.		
5	(e) Based on the information presented and in accordance with Public Works Code		
6	Article 5, this Board determines that the actions requested are appropriate and in the public		
7	interest.		
8	Section 2. Pursuant to Public Works Code Section 161(I), this Board hereby authorizes		
9	the sale of the street flower market permit for the site located on the south side of Market		
10	Street within 100 feet of the west line of 5 th Street to The Lurie Company. This Board further		
11	directs that the sale of the subject permit shall occur within thirty (30) days.		
12	Section 3. The San Francisco Public Works Code is hereby amended by amending

1	On the east sidewalk of Stockton Street within 100 feet south of the southerly		
2	line of Geary Street.		
3	On the west sidewalk of Stockton Street within 100 feet north of the northerly		
4	line of Ellis Street.		
5	On the east sidewalk of Stockton Street within 100 feet north of the northerly line		
6	of O'Farrell Street.		
7	On the north sidewalk of Post Street within 50 feet west of 250 Post Street.		
8	The Powell Street Flower Market		
9	On the east sidewalk of Powell Street between 25 feet and 100 feet south of the		
10	southerly line of Geary Street.		
11	On the west sidewalk of Powell Street within 100 feet north of the northerly line		
12	of Eddy Street.

14	On the south sidewalk of Market Street facing the location of 835 Market Street.

6	The Harvey Milk Plaza Flower Market		
7	On the west sidewalk of Castro Street north of the main entrance to the Harvey

9	Section 4. The Board authorizes the Director of the Department of Public Works to		
10	take any and all actions necessary to ensure that The Lurie Company removes the street		
11	flower market located on the south side of Market Street within 100 feet of the west line of 5 th		
12	Street in a diligent and safe manner and restores the subject right-of-way.
