WHEREAS, The Aging and Adult Services Commission voted to recommend proposed settlement up to \$90,000 at its June 20, 2018, meeting; and

WHEREAS, The Department of Aging and Adult Services has since agreed to terms with Claimant that value the claim for one estate at \$39,991.97 and the other estate at \$36,874.23, and because the final amount is subject to approval by the Probate Court, the Department of Aging and Adult Services recommends settlement of the full claim by payment up to \$80,000; now, therefore, be it
