Subject: **File No. 250371.** Hearing of the Board of Supervisors sitting as a Committee of the Whole on July 8, 2025, at 3:00 p.m., to consider renewal and expansion of a property-based business improvement district, known as the Ocean Avenue Community Benefit District, pursuant to the California Property and Business Improvement District Law of 1994 (Streets and Highways Code, Sections 36600 et seq.), and City and County of San Francisco Business and Tax Regulations Code, Article 15; scheduled pursuant to Resolution No. 208-25; adopted on May 6, 2025.

Pursuant to the California Property and Business Improvement District Law of 1994 (Streets and Highways Code 36600 et seq.) and City and County of San Francisco Business and Tax Regulations Code, Article 15, this is to notify you that a petition signed by property owners to renew a property and business improvement district in your area was received by the Clerk of the Board of Supervisors on April 8, 2025. The proposed renewed district would be known as the Ocean Avenue Community Benefit District (CBD).

If this Property and Business Improvement District is renewed, it would authorize assessments against real property in the district for fifteen and one-half (15 ½) years with services to be implemented January 1, 2026, through June 30, 2040. The CBD would fund and provide the following services:

- 1) Cleaning and Maintenance;
- 2) Streetscape Improvement and Beautification;
- 3) Marketing and Economic Development; and
- 4) Management and Operations.


Renewal of the property and business improvement district is subject to the approval of the Board of Supervisors after a noticed public hearing and a vote by the property owners who would be subject to the assessments. Following public comment, ballots submitted by the property owners in the proposed renewed and expanded CBD will be counted by the Department of Elections and the results will be announced by the Board of Supervisors. If the ballot election does not result in a majority protest against renewal of the proposed district, the Board of Supervisors may vote to renew the CBD.

議題: 檔案編號 250371。市參事會將於2025年7月8日下午3時正，以全體委員會名義舉行聽證會，審議一項根據《1994年加州物業及商業改善區法》（《街道及公路法典》第36600條及其後條文）及《三藩市商業及稅務條例》第15章所提出的議案，擬續期並擴展名為「海洋大道社區福利區」（Ocean Avenue Community Benefit District）的物業及商業改善區。是次聽證會乃根據2025年5月6日通過的第208-25號決議安排舉行。

根據1994年《加州物業及商業改善區法》（《街道及公路法典》第36600條及其後條文）以及三藩市市及縣《商業及稅務規例》第15章，茲通知閣下：市參事會書記處已於2025年4月8日接獲一份由物業業主簽署的呈請書，建議在閣下社區續期並擴展一個物業及商業改善區。擬續期的區域將命名為「海洋大道社區福利區」（Ocean Avenue Community Benefit District）。

若該改善區獲續期，將對區內物業徵收評估費，為期十五年半，由2026年1月1日至2040年6月30日。所得款項將用於提供以下服務：

- 1) 清潔與維護
- 2) 街景改善與美化
- 3) 市場推廣與經濟發展
- 4) 管理與營運

有關續期事宜，須經市參事會舉行公開聽證並獲受影響業主投票通過。於公眾意見收集後，選舉部將點算投票選票，並由市參事會公布結果。若投票結果未構成對擬議續期區域的多數抗議，市參事會將可表決通過續期該社區福利區。

El distrito propuesto renovado se conocerá como el Distrito de Beneficio Comunitario de Ocean Avenue (CBD, *siglas en inglés*).




