
8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. The San Francisco Municipal Elections Code is hereby amended by adding
10 Section 410, to read as follows:

11 Sec. 410. POSTAGE PAID FOR ABSENTEE BALLOTS. In addition to the requirements
12 imposed by Division 3, Chapter 1 of the California Elections Code, each absent voter identification
13 envelope shall be returnable to the Department of Elections with postage paid by the Department of
14 Elections. The Director of Elections, or the Director's designee, is authorized to enter into any
15 contracts with the United States Postal Service that the Director determines are necessary and
16 advisable to implement this Section.




