4 **Resolution retroactively authorizing the Department of Public Health to accept and**  
5 **expend a grant in the amount of \$134,610 from the United States Department of Health**  
6 **and Human Services National Institutes of Health through the Magee-Womens**  
7 **Research Institute and Foundation for participation in a program, entitled “Leadership**  
8 **and Operations Center (LOC): Microbicide Trials Network,” for the period of**  
9 **December 1, 2019, through November 30, 2020.**

11 WHEREAS, The United States Department of Health and Human Services National  
12 Institutes of Health, through Magee-Womens Research Institute and Foundation (MWRIF) as  
13 a pass-through entity, has agreed to fund the San Francisco Department of Public Health  
14 (DPH) in the amount of \$134,610 for participation in a program, entitled “Leadership and  
15 Operations Center (LOC): Microbicide Trials Network,” for the period of December 1, 2019,  
16 through November 30, 2020; and

17 WHEREAS, The purpose of the grant is to develop safe and efficacious HIV prevention  
18 strategies; and

19 WHEREAS, Grant funds will be used for the development, implementation and  
20 operation of the protocol; and

21 WHEREAS, Grant funds will be used to develop and establish study-specific working  
22 groups as needed to achieve the aim of the study; and

23 WHEREAS, Grant funds will be used to monitor participant safety through the Protocol  
24 Safety Review Team, maintaining high data quality, adhering to the proposed project  
25 schedule, and facilitating decision making within the protocol team; and

1           WHEREAS, Grant funds will be used for analysis and manuscript preparation to ensure  
2 timely publication of results and dissemination of findings from the study; and

3           WHEREAS, The grant does not require an Annual Salary Ordinance Amendment; and

4           WHEREAS, A request for retroactive approval is being sought because DPH received  
5 the full award agreement on November 28, 2019, for a project start date of December 1, 2019;  
6 and

7           WHEREAS, The grant budget includes a provision for indirect costs in the amount of  
8 \$26,922; now, therefore, be it


9           RESOLVED, That DPH is hereby authorized to retroactively accept and expend a grant

11          FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and  
12 expend the grant funds pursuant to Administrative Code, Section 10.170-1; and, be it


13          FURTHER RESOLVED, That the Director of Health is authorized to enter into the  
14 Agreement on behalf of the City.




