Through my clinical practice, advocacy efforts, and community work, I have seen firsthand the disparities urban underserved youth and their families experience in terms of access to healthcare and social services, their experience with the healthcare and social service system, and their overall health. Prior to medical school, I trained as a chef. My culinary background and community and advocacy work led me to combine clinical practice with efforts to maximize children's health and address food insecurity through non-traditional initiatives. As one of four UCSF Pediatric Leadership for the Underserved (PLUS) residents in my residency group, I received adaptive leadership training and my clinical training included a focus on structural causes of healthy inequity. Through PLUS, I learned about pediatricians' unique opportunities to influence social determinants of health, like food insecurity, and patients' challenges within our complex healthcare and social services system. Now, as a pediatrician at Kaiser Permanente, I help teach monthly cooking classes to patients, staff, and community members, advise on culturally relevant food as medicine programming and supports for children, adolescents, and their families within the clinical context at Kaiser, and work with Jim Illig to review and support food and nutrition programming at Bay Area community organizations.

Business and/or professional experience:

Before medical school, I worked with underserved Cleveland public elementary schools to incorporate better nutrition into classroom curricula and lunchrooms, and taught cooking classes in New York City for underserved children and their families to encourage practical, cost-effective, culturally relevant, healthy eating and cooking. In medical school in Baltimore, I co-organized a Latino Health elective and helped create a Latino Health Pathway that included a lecture series, community clinical experiences working with Latino patients, and assistance in certifying students as proficient to communicate with patients in Spanish. During my pediatrics residency, I consulted for a new community partnership school in East Palo Alto on their nutrition and culinary programming as well as strategies to address food insecurity amongst their students and received an American Academy of Pediatrics (AAP) CATCH Grant to conduct a needs assessment to examine use of school-based food pantries among diverse, underserved families, including assessing their preferences on how to receive information about nutrition, healthy cooking and recipes. Since November 2018, I have been working as a Pediatric Culinary Medicine Strategies Consultant for Alameda County to help with their county-wide Food as Medicine (FAM) initiatives, including Healthy Food, Healthy Families. In this role, I work with Community Food Champions, Alameda County Community Food Bank staff, All In staff, individuals from Children's Hospital Oakland and the Children's Hospital Oakland Research Institute, as well as physicians and other staff members from several federally qualified health centers in Alameda County. Together, we have published a free FAM in Healthcare Toolkit, led at least 12 FAM workshops with community members and at least 6 FAM trainings at community clinics.

Civic Activities:

In February 2016, I joined the advisory board of the SFUSD Urban Agriculture Career Technical Education Academy, where I work with Mission High School in their efforts to increase scratch cooking and improve school food, advise students on their senior projects and food and nutrition policy opportunities, and connect students with community members and partners in food and nutrition industries (including the Food Security Task Force). In April 2019, I became a San Francisco County Champion Provider Fellow where along with other healthcare provider fellows and the SF Department of Public Health and School District, we use our expertise in nutrition, food insecurity, and obesity prevention to influence local policy, systems, and environmental changes on related topics. Through this fellowship, I have been able to work closely with Dr. Rita Nguyen and Erin Franey from SFDPH, Katie Ettman from SPUR, and others on a Medicaid waiver proposal to cover medically-supported food and nutrition. In addition, I have submitted public comment to the USDA and Department of Homeland Security regarding scientific evidence for the development of the 2020-2025 Dietary Guidelines for children aged 0-2 years old, Public charge, and SNAP eligibility. Finally, whenever possible, I try to attend the San Francisco Food Insecurity Taskforce meetings, including the strategic plan implementation subgroup meetings. I attended a SSB Distributor Tax Town Hall Meeting and I intend to start attending the Shape Up SF Coalition meetings.

Board Qualifications:

The Food Security Task Force was established to recommend legislative action and city-wide strategies to the Board of Supervisors that would increase participation in federally funded programs such as CalFresh (known nationally as SNAP and formally as food stamps), Summer Food Service, the Child and Adult Care Food Program, the Homeless Children Nutrition Program, the Special Supplemental Nutrition Program for Women, Infants and Children (WIC), the School Lunch Program, and the National School Breakfast Program. The Task Force shall also provide general advice and assistance to the Board of Supervisors with regard to funding priorities, legislative action, and city policies on addressing hunger and enhancing the food security of San Francisco residents, in addition to any other issues within the Task Force's expertise.

The Food Security Task Force shall consist 20 members appointed by the Board of Supervisors, City department heads, or the San Francisco Unified School District. Members shall serve at the pleasure of their respective appointing authorities.

Seat 1: Shall be an employee of the Department of Human Services, appointed by the Executive Director of the Human Services Agency.

Seat 2: Shall be an employee of the Department of Public Health-Nutrition Services, appointed by the Director of Health.

Seat 3: Shall be an employee of the Department of Aging and Adult Services, appointed by the

Executive Director of the Human Services Agency.

Seat 4: Shall be an employee of the Department of Public Health-Food Security, appointed by the Director of Health.

Seat 5: Shall be an employee of the Department of Children, Youth and Their Families, appointed by the Director of the Department of Children, Youth and Their Families.

Seat 6: Shall be an employee of the Department of Homelessness and Supportive Housing, appointed by the Director of the Department of Homelessness and Supportive Housing.

Seat 7: Shall be an employee of the Recreation and Park Department's Urban Agriculture Program, appointed by the General Manager of the Recreation and Park Department.

Seat 8: Shall be an appointee of the San Francisco Unified School District, if the District chooses to appoint a member.

The Board of Supervisors shall appoint:

Seats 9 through 19: Shall be representatives of community-based organizations that provide nutritional support and increase the food security of San Francisco residents, including but not limited to representatives from organizations serving food in the following program types: home-delivered meals, congregate meals for seniors, food bank, free dining room, multi-service agency serving families and youth, shelter meals, faith-based organizations, food retail (farmers markets, grocery stores), and hospital and health clinics - no organization shall have more than one representative; nominated by the Food Security Task Force and appointed by the Board of Supervisors.

Seat 20: Shall be a member of the public, nominated by the Food Security Task Force and appointed by the Board of Supervisors.

The Department of Public Health shall provide clerical assistance and logistical support to the Task Force and its committees.

Reports: The Food Security Task Force shall prepare an annual assessment to the Board of Supervisors of the state of hunger and food insecurity in San Francisco. The report may include recommendations for funding, programs, and policy.

Sunset Date: The Task Force shall terminate on July 1, 2021.
