3 **Resolution accepting and expending a gift-in-place, valued at up to \$12,000,000, from**  
4 **the Stern Grove Festival Association to the Recreation and Park Department to fund**  
5 **construction for the renovation of Concert Meadow facilities in Sigmund Stern Grove**  
6 **and Pine Lake Park.**

8 WHEREAS, The City owns real property located in Sigmund Stern Grove and Pine  
9 Lake Park known as "The Concert Meadow"; and,

10 WHEREAS, Through a series of community meetings, a conceptual improvement plan  
11 was developed by the Recreation and Park Department, the Department of Public Works and  
12 the Office of Lawrence Halprin and approved by the Recreation and Parks Commission on  
13 November 20, 2003 per the Resolution No. 0312-008; and,

14 WHEREAS, The Stern Grove Festival Association is a non-profit organization  
15 committed to offering an admission-free, performing arts series every summer in the Sigmund  
16 Stern Grove Concert Meadow; and,

17 WHEREAS, The Stern Grove Festival Association is proposing to fund construction for  
18 the renovation of Concert Meadow facilities as a gift-in-place ("Gift"), valued at up to  
19 \$12,000,000, in Sigmund Stern Grove, to the City and County of San Francisco; and,

20 WHEREAS, On May 20, 2004, the Recreation and Park Commission recommended to  
21 the Board of Supervisors to accept and expend the Gift as Resolution No. 0405-004; now,  
22 therefore, be it

23 RESOLVED, That the Board of Supervisors authorizes the General Manager of the  
24 Recreation and Park Department to accept and expend the Gift in place valued at up to
