3 **Resolution authorizing the San Francisco Department of Public Health (SFDPH) to**  
4 **approve a no-cost extension of grant funds from the Substance Abuse and Mental**  
5 **Health Services Administration (SAMHSA) in the amount of \$309,049 in funds left over**  
6 **from the prior grant year of September 30, 2004 to September 29, 2005, extending the**  
7 **term from September 29, 2005, to September 29, 2006, and changing grant-funded**  
8 **positions; for the new period of September 30, 2005, to September 29, 2006.**

10 WHEREAS, SFDPH was awarded a grant from SAMHSA in the amount of \$499,999  
11 for the third year of a three year grant to establish a homeless addict vocational and  
12 educational network in San Francisco for the period of September 30, 2004, to September 29,  
13 2005 and to add two new positions not included in the original grant; and,

14 WHEREAS, The Board of Supervisors adopted the resolution to accept these funds on  
15 November 2, 2004, under Resolution No. 674-04; and,

16 WHEREAS, \$309,049 in these third year funds are left over from the September 30,  
17 2004 to September 29, 2005 grant year; and,

18 WHEREAS, SFDPH requests approval of a no-cost extension for the use of these left-  
19 over funds for evaluation, continuing aftercare services, and follow-up interviews with third  
20 year clients; and,

21 WHEREAS, Changes in the grant-funded positions for these extended services require  
22 approval by the Board of Supervisors; and,

23 WHEREAS, SAMHSA has approved the use of the left-over funds for these purposes;  
24 and,

1 WHEREAS, The grant budget includes provision for indirect costs of \$4,289; now,  
2 therefore, be it


3 RESOLVED, That SFDPH is hereby authorized to expend a no-cost extension of grant  
4 funds from SAMHSA in the amount of \$309,049; and, be it

5 FURTHER RESOLVED, That SFDPH is hereby authorized to accept and expend the  
6 grant funds in accordance with the requirements set forth in the Agreement pursuant to San  
7 Francisco Administrative Code section 10-170-1; and, be it

8 FURTHER RESOLVED, That the Controller is directed to designate the positions  
9 created under the grant as "G" or grant-funded positions, which would terminate when the  
10 grant expires.


