

WHEREAS, Club Allure, Inc., is seeking the transfer of a Type-48 on-sale
general public premises liquor license to do business as AJ's Bar, located at 1250
Market Street (District 6); and

WHEREAS, The Planning Department has verified that the area is properlyzoned and recommends approval; and

16 WHEREAS, The Police Department has filed zero protests and zero letters of 17 support with the Department of Alcoholic Beverage Control under California Business 18 and Professions Code, Section 24013, and recommends that the Department of 19 Alcoholic Beverage Control issue the liquor license with conditions; and

20 WHEREAS, The conditions recommended by the Police Department are the 21 following: 1) Petitioner(s) shall actively monitor the area under their control in an effort 22 to prevent the loitering of persons on any property adjacent to the licensed premises as 23 depicted on the ABC-253; 2) The petitioner(s) shall be responsible for maintaining free 24 of litter the area adjacent to the premises over which they have control, as depicted on 25 ABC-253; 3) (1) Except as provided in Condition 2 below, no noise shall be audible

A violation of the entertainment or amplified sound noise conditions of the 7 Entertainment Permit, as determined by the San Francisco Entertainment Commission 8 (or any successor agency), shall be deemed to be a violation of this Condition. Any 9 noise that is not subject to, or is beyond the scope of, the Entertainment Permit shall be subject to Condition 1 above. "Entertainment Permit" means any of the following: a Just 10 Add Music permit, a Limited Live Performance permit, a Place of Entertainment permit, 11 12 a Fixed Place Amplified Sound permit, or any similar such permit issued by the San 13 Francisco Entertainment Commission; now, therefore, be it

14 RESOLVED, That in accordance with California Business and Professions Code, 15 Section 23958.4, the Board of Supervisors of the City and County of San Francisco 16 hereby determines that transfer of a Type-48 on-sale general public premises liquor 17 license to Club Allure, Inc., doing business as AJ's Bar, located at 1250 Market Street, 18 will serve the public convenience or necessity of the City and County of San Francisco; 19 and, be it



Hello,

I am a Certified Public Accountant (CPA) and I began my working career as a cashier at McDonalds. With limited resources and my starting salary was very small, I learned how to manage my life very efficiently. I incorporated this philosophy into my 16 years as the owner and manager of Club 93. Our most famous item was having free pizza for customers. This allowed customers not only to enjoy a free meal but also relax with their family or colleagues. Upon completion of our lease in July 2022, we started looking for a better location and a reasonable priced rent. I am very lucky to lease a property at 1250 Market Street, suite 101 as our new location and will be using DBA of AJ'S Bar. We are moving approximately a block away (from 93 9th street) and we will be in the same district.

The main reason of the move was because of the Illegal activities around the previous location and degradation condition of the building. Over the years we have followed the laws also made sure we do not allow any illegal activities in our premise. AJ'S bar will be following the 2010 pricing model since we are surprised to see that drinks cost around \$12 to \$25. Our house drinks and personal pan pizza will be costing around \$6 plus tax. We will be serving breakfast sandwiches for \$4 plus tax and coffee/tea for \$2 plus tax. With this pricing our business will be a necessity for middle class residents of San Francisco.
