12 WHEREAS, The Mission Hiring Hall was founded in 1971 initially  
13 focusing on the serious employment barriers faced by the Mission  
14 neighborhood's predominantly Latino residents; and,

15 WHEREAS, The Mission Hiring Hall is now celebrating their  
16 Thirtieth Anniversary and, in those thirty years, they have helped  
17 thousands of low-income clients realize the many rewards of working;  
18 and,

19 WHEREAS, For more than twenty years, the Mission Hiring Hall has  
20 provided employment services on behalf of various departments and  
21 agencies of the City of San Francisco, and the Private Industry  
22 Council has funded MHH's job training and placement program in the  
23 printing trades since 1993; and,

24 WHEREAS, MHH is a member organization of the Community Workforce  
25 Collaborative which documents compliance with wage, affirmative
