9 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. The San Francisco Administrative Code is hereby amended by adding
12 Section 12S.1, to read as follows:

13 **SEC. 12S.1. WORKING FAMILIES CREDIT PROGRAM.**

14 The Working Families Credit Program is hereby created in the Office of the Treasurer,
15 Beginning in Fiscal Year 2005-2006, the program will provide an incentive payment to qualified
16 working families from the Treasurer's Working Families Credit Fund established in
17 Section 10.100-347. The incentive payment shall be based on a percentage of the family's federal
18 Earned Income Tax Credit (EITC). The Treasurer shall work with the Local EITC Working
19 Group, other City departments, and community stakeholders to develop the program. This legislation is
20 not intended to result in a reduction in the level of public assistance to which participants in the
21 Working Families Credit Program would otherwise be entitled..

2 Section 10.100-347, to read as follows:


3 **SEC. 10.100-347. TREASURER'S WORKING FAMILIES CREDIT FUND.**

4 (a) Establishment of Fund. The Treasurer's Working Families Credit Fund is established as a
5 category eight fund for the purpose of receiving all public monies and gifts, donations and
6 contributions of money which may from time to time be received by the City and County through the
7 Treasurer for the purpose of implementing the Working Families Credit Program established in
8 Chapter 12S.

9 (b) Use of Fund. All expenditures from such fund shall be made for the purpose of
10 administering and implementing the Working Families Credit Program established in Chapter 12S.
11 beginning with tax year 2004.




