4 **a subcommittee of the Budget and Finance Committee.**

9 MOVED, That the Board of Supervisors of the City and County of San Francisco
10 hereby amends Rule 5.1 of the Rules of Order of the Board of Supervisors to read as follows:

11 5.1 Budget and Finance Committee. The Budget and Finance Committee shall be
12 referred appropriation ordinances, and measures concerning bond issues, taxes, fees and
13 other revenue measures, redevelopment, and real estate. The Budget and Finance
14 Committee shall also be referred the annual appropriation and annual salary ordinances. The
15 Budget and Finance Committee shall hold a public hearing on the Mayor's budget instructions
16 to City Departments for each annual City budget after the instructions are released.

17 The Budget and Finance Committee shall be comprised of three full-time members
18 except that beginning on April 1 of each year the Committee shall be comprised of five
19 members and shall remain a Committee of five members until the Board of Supervisors
20 adopts the annual appropriation and salary ordinances. Following the adoption of the annual
21 appropriation and salary ordinances by the Board of Supervisors, the committee will be
22 reduced to the three full-time members.

23 Beginning on April 1 of each year, and until the Board of Supervisors adopts the annual
24 salary and appropriation ordinances, there shall be a subcommittee of the Budget and
25 Finance Committee consisting of three members. Unless otherwise designated by the

1 President, the members of the subcommittee shall be the full-time members of the Budget
2 and Finance Committee. The subcommittee may consider any matters assigned to the
3 Budget and Finance Committee except the annual appropriation and salary ordinances or the
4 Mayor's budget instructions.
