3 **Resolution authorizing the Airport Commission to retroactively accept and expend a**
4 **grant of \$1,700,000 from the California Air Resources Board for the acquisition and**
5 **operation of a hydrogen vehicle fueling station.**

7 WHEREAS, Pursuant to its Clean Vehicle Policy, the Airport seeks to reduce vehicle
8 emissions in the region and on terminal roadways; and

9 WHEREAS, The California Air Resources Board (CARB) assists public agencies in
10 implementing advanced alternative fuel projects; and,

11 WHEREAS, The Airport Commission in Resolution 09-0021 approved seeking,
12 accepting, and expending funds for a hydrogen vehicle fueling station; and

13 WHEREAS, The Airport would administer the subject grant, disburse incentive funds to
14 the designated fueling station operator, and provide CARB with information concerning the
15 project; and

16 WHEREAS, No Airport or City funds would be used for this project; and

17 WHEREAS, The project would continue the Airport's leadership role in advancing near-
18 zero-emission alternative fuel technologies; and


19 WHEREAS, The Airport proposes to maximize use of available grant funds on program
20 expenditures by not including indirect costs in the grant budget;


21 WHEREAS, the grant does not require an ASO amendment; now, therefore, be it


22 **RESOLVED**, That pursuant to San Francisco Administrative Code §10.171, the Board
