

1 [URGING THE SAN FRANCISCO DEPARTMENT OF PUBLIC WORKS TO CREATE AND  
2 IMPLEMENT A QUALITY OF LIFE NEIGHBORHOOD EFORUM].

3 WHEREAS, Input from members of the public is crucial in  
4 identifying and resolving neighborhood issues; and,

5 WHEREAS, Since 1996, the San Francisco Department of Public  
6 Works has sponsored and coordinated 16 Quality of Life-Neighborhood  
7 Forums reaching more than 50 neighborhoods in San Francisco; and,

8 WHEREAS, City representatives respond to specific concerns and  
9 neighborhood issues brought up at or before each Forum; and,

10 WHEREAS, These Forums have generated numerous City services  
11 beneficial to the targeted neighborhoods; and,

12 WHEREAS, The Department of Public Works has developed  
13 substantial experience as the lead agency providing quality customer  
14 service to the residents of San Francisco through their Quality of  
15 Life-Neighborhood Forums; and,

16 WHEREAS, The technology exists to provide members of the public  
17 with an opportunity to use the Internet to give feedback to the City  
18 on neighborhood issues; now, therefore be it

19 RESOLVED, That the Board of Supervisors of the City and County  
20 of San Francisco urges the Department of Public Works to make the  
21 benefits of the Quality of Life-Neighborhood Forums more widely  
22 available to members of the public by creating and implementing a  
23 Quality of Life-Neighborhood eForum through the Internet; and, be it

24 FURTHER RESOLVED, That the Board of Supervisors of the City and  
25 county of San Francisco urges the Department of Public Works to work

1 in partnership with other City agencies to make the eForum available  
2 to members of the public who do not have access to the Internet.


