1 OPPOSING THE REQUEST FOR THE TRANFER OF A TYPE 20 OFF-SALE BEER AND WINE ALCOHOLIC
2 BEVERAGE CONTROL LICENSE FOR MUHAMMAD DAHER AND KHALED ZOUBI FOR NORTH BEACH
3 MARKET, FROM 1262 STOCKTON STREET TO 536 BROADWAY STREET, AND DETERMINING THAT IT
4 WILL NOT SERVE THE PUBLIC CONVENIENCE AND NECESSITY OF THE PEOPLE OF THE CITY AND
5 COUNTY OF SAN FRANCISCO, IN ACCORDANCE WITH SECTION 23958.4 OF THE CALIFORNIA
6 BUSINESS AND PROFESSIONS CODE.

7 WHEREAS, Muhammad Daher and Khaled Zoubi are seeking the transfer of a Type 20
8 off-sale beer and wine alcoholic beverage control license for North Beach Market
9 from 1262 Stockton Street to 536 Broadway Street; and

10 WHEREAS, At the Housing and Neighborhood Services Committee meetings of
11 October 15, 1998, November 19, 1998 and January 21, 1999, residents of the area
12 testified against the tranfer of a liquor license at this location; and

13 WHEREAS, The Police Department reports the area has an undue concentration
14 of licensed premises and has a high crime rate; and

15 WHEREAS, The Police Department recommends that the liquor license application
16 be approved with conditions; now, therefore, be it

17 RESOLVED, That the Board of Supervisors opposes the tranfer of a Type 20 off-sale
18 beer and wine alcoholic beverage control license to Muhammad Daher and Khaled Zoubi
19 for North Beach Market, 536 Broadway Street, and determines that it will not serve
20 the public convenience and necessity of the people of the City and County of San
21 Francisco, in accordance with Section 23958.4 of the California Business and
22 Professions Code; and be it

23 FURTHER RESOLVED, That the Board of Supervisors respectfully request that the
24 Department of Alcoholic Beverage Control deny this application.


