3 **Resolution retroactively authorizing the Office of Economic and Workforce**  
4 **Development to accept and expend a grant in the amount of \$60,000 from the Humboldt**  
5 **State University Sponsored Programs Foundation for the GO-Biz Capital Infusion**  
6 **Program for the period of October 1, 2014, through September 30, 2015.**

8 WHEREAS, The Office of Economic and Workforce Development (OEWD) won a bid  
9 to be the local host of the San Francisco Small Business Development Center (SFSBDC)  
10 early this year; and

11 WHEREAS, The mission of the SFSBDC is to engender entrepreneurship and cultivate  
12 small business success in the City and County of San Francisco by providing high-quality  
13 technical support, training and in-depth financial analysis for start-up and existing companies;  
14 and

15 WHEREAS, For the SFSBDC to assist more entrepreneurs, help them access capital,  
16 and build and grow their entrepreneurial base, OEWD responded to a request for proposals  
17 from the Governor's Office Of Business and Economic Development (GO-Biz); and

18 WHEREAS, OEWD was awarded \$60,000 by Humboldt State University  
19 Sponsored Programs Foundation for the GO-Biz Capital Infusion Program; and

20 WHEREAS, The grant award requires \$60,000 in matching funds; and

21 WHEREAS, This grant does not create any new positions and will not require  
22 an amendment to the Annual Salary Ordinance; and

23 WHEREAS, The grant terms prohibit including indirect costs in the grant  
24 budget; now, therefore, be it

1 RESOLVED, That OEWD is hereby authorized to retroactively accept and expend a  
2 grant in the amount of \$60,000, for the period of October 1, 2014 through September 30,  
3 2015; and, be it

4 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of  
5 indirect costs in the grant budget; and, be it

6 FURTHER RESOLVED, That OEWD is hereby authorized to retroactively accept and  
7 expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and,  
8 be it

9 FURTHER RESOLVED, That the Director of OEWD is authorized to enter into the  
10 agreement on behalf of the City;



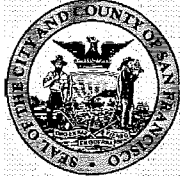


