3 **Resolution urging California Governor Arnold Schwarzenegger to withdraw his**
4 **proposal to eliminate funding for the California Seismic Safety Commission.**

6 WHEREAS, With passage of the Seismic Safety Commission Act in 1975, the Seismic
7 Safety Commission was established to advise the Governor, Legislature, and state and local
8 governments on ways to reduce earthquake risk; and,

9 WHEREAS, The Commission was formed in response to a need to provide a
10 consistent policy framework and a means for coordinating on a continuing basis the
11 earthquake-related programs of agencies at all governmental levels and their relationships
12 with elements of the private sector involved in practices important to seismic safety; and,

13 WHEREAS, The Commission is responsible for managing California's Earthquake
14 Hazards Reduction Program, reviewing seismic activities funded by the state, providing a
15 consistent policy direction for earthquake-related programs for agencies at all government
16 levels, proposing and reviewing earthquake-related legislation, conducting public hearings on
17 seismic safety issues, recommending earthquake safety programs to governmental agencies
18 and the private sector and investigating and evaluating earthquake damage and
19 reconstruction efforts following damaging earthquakes; and,

20 WHEREAS, Recently, Governor Arnold Schwarzenegger proposed to eliminate funding
21 for the California Seismic Safety Commission; and,

22 WHEREAS, In the wake of the recent failure of FEMA to respond effectively to the victims of
23 Hurricane Katrina, the Governor's proposal to eliminate funding for emergency preparedness
24 bodies such as the California Seismic Safety Commission is not appropriate; now, therefore,
25 be it
