URGING THE CALIFORNIA STATE LEGISLATURE AND GOVERNOR DAVIS TO APPROVE SENATE BILL 89 RELATING TO ENVIRONMENTAL EFFECTS ON MINORITY AND LOW-INCOME POPULATIONS.

WHEREAS, According to a federal Environmental Working Group study, communities of color are three times more likely to be exposed to unsafe levels of air pollutants than white neighborhoods; and,

WHEREAS, The rates of breast cancer deaths, asthma, cervical cancer, prostate cancer in the Bayview-Hunters Point neighborhood in San Francisco, an area which is 60 percent African American and surrounded by industrial development and toxic waste sites, are disproportionately higher than other parts of San Francisco; and,

WHEREAS, The California Environmental Protection Agency, the Resources Agency, and the State Department of Health Services implement, administer, and enforce various environmental laws and regulations in the state; and,

WHEREAS, The California State Legislature is currently considering Senate Bill 89, which was introduced by Senator Escutia; and,

WHEREAS, Senate Bill 89 would create a Working Group on Environmental Justice for the purpose of identifying disproportionately high and adverse human health or environmental effects on minority and low-income populations; and,

WHEREAS, Senate Bill 89 would require the Working Group on Environmental Justice to provide guidance to the California Environmental Protection Agency, the Resources Agency, and the State Department of Health Services; and,

WHEREAS, Senate Bill 89 would require the Working Group on Environmental Justice, the California Environmental Protection Agency, the Resources Agency, and the State

Department of Health Services to take specified actions to develop an agency-wide strategy to identify and address issues relating to environmental justice; and,

WHEREAS, Senate Bill 89 is on file with the Clerk of the Board of Supervisors in File

No. 990095; now, therefore, be it

RESOLVED, That the San Francisco Board of Supervisors endorses Senate Bill 89 and urges the Legislature and Governor to approve this legislation; and, be it

FURTHER RESOLVED, That a copy of this resolution be forwarded to his Honor, the Mayor, with a request that he transmit copies to the delegation from San Francisco in the State Legislature, as well as Governor Davis, with a request they take all action necessary to achieve the objectives of this resolution.
