3 **Ordinance authorizing settlement of the lawsuit filed by Leslie Drapkin against the City**  
4 **and County of San Francisco for \$75,000; the lawsuit was filed on July 20, 2020, in San**  
5 **Francisco Superior Court, Case No. CGC-20-585425; entitled Leslie Drapkin v. City and**  
6 **County of San Francisco, et al.; the lawsuit involves alleged personal injury on a City**  
7 **sidewalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Leslie Drapkin v. City and County of  
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC-20-585425 by the  
13 payment of \$75,000. The lawsuit involves alleged personal injury on a City sidewalk.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 July 20, 2020, and the following parties were named in the lawsuit: plaintiff: Leslie Drapkin;  
16 defendants: City and County of San Francisco, Panaroma Condominium Owners Assoc.
