

1 [Sewer Emergency]

2 APPROVING THE EXPENDITURE OF FUNDS FOR THE EMERGENCY WORK TO
3 REPLACE THE STRUCTURALLY INADEQUATE SEWER ON 19th STREET FROM
4 GUERRERO STREET TO DOLORES STREET.

5 WHEREAS, On January 14, 1998, PUC Sewer Operations identified an emergency
6 condition on 19th Street from Guerrero Street to Dolores Street; and

7 WHEREAS, The existing sewer had collapsed, and immediate replacement was required in
8 order to protect the health, welfare, and property of the Citizens of San Francisco; and

9 WHEREAS, DPW's Bureau of Engineering prepared the Plans and Specifications for
10 Contract No. CW-149, "19th Street Emergency Sewer Replacement" to replace the existing 18-
11 inch diameter vitrified clay pipe (VCP) sewer with 589 feet of 12-inch diameter VCP sewer in
12 19th Street from Guerrero Street to Dolores Street; and

13 WHEREAS, The Contractor, K. J. Woods Construction, Inc. began the emergency work on
14 January 28, 1998 and completed it on February 17, 1998; and

15 WHEREAS, The total estimated project cost is \$132,602, of which \$99,602 is for the
16 construction contract. Funds for this project are available from the Repair and Replacement Fund
17 (Fund 5C/CPF/R&R, FAMIS Project No. CENRNRR953, Job Order No. 1575N); and

18 WHEREAS, The Public Utilities Commission, in accordance with the provisions of Section
19 6.30 of the Administrative Code of the City and County of San Francisco, declared the existence
20 of an emergency; now, therefore, be it

21 RESOLVED, That this Board of Supervisors hereby approves the expenditure of funds for
22 the emergency work to repair the structurally inadequate sewer on 19th Street from Guerrero
23 Street to Dolores Street.




