10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
12 authorizes the City Attorney to settle the action entitled Ladies & Gentlemen, Inc. v. City and  
13 County of San Francisco Police Department, San Francisco Superior Court, Case No. CPF-  
14 24-518702 by the payment of \$40,612.46. The lawsuit involves claims related to the  
15 Sunshine Ordinance and California Public Records Act.
