12 Section 2. The above-named action was filed in the United States District Court for the
13 Northern District of California on October 4, 2010, and the following parties were named in the
14 lawsuit: Plaintiff Fred Broussard; Defendants City and County of San Francisco and Joseph
15 McCloskey.


