

1 [Emergency Declaration - Airport Runways 19L and 19R Seawall Erosion - Estimated Cost of  
2 Repairs Exceeds \$250,000]

3 **Resolution approving the Airport Director's declaration of an emergency for seawall**  
4 **erosion at the ends of Airport Runways 19L and 19R, estimated to cost more than**  
5 **\$250,000 to repair, pursuant to Administrative Code, Section 6.60(b).**

7 WHEREAS, The Airport is protected from flooding by a bayside seawall system; and

8 WHEREAS, On July 18, 2016, Airport staff observed significant erosion damage to the  
9 seawall at the ends of runways 19L and 19R; and

10 WHEREAS, A geotechnical consultant assessed the condition of the wall and found  
11 erosion and seepage problems and a potential sinkhole at the end of runways 19L and 19R;  
12 and

13 WHEREAS, The geotechnical consultant concluded that this portion of the seawall  
14 needs immediate repair or the Airport risks flooding of the airfield during the upcoming storm  
15 season; and

16 WHEREAS, The Airport Director has determined these circumstances constitute an  
17 imminent threat to Airport property that may interrupt aircraft arrival and departures and  
18 impact the general public; and

19 WHEREAS, Under authority granted by Administrative Code, Section 6.60(b), the  
20 Airport Director declared an emergency on September 6, 2016, and gave notice of the  
21 emergency declaration to the Board of Supervisors, Mayor, Controller, and Airport  
22 Commission; and

23 WHEREAS, Airport staff has analyzed the circumstances extensively and determined  
24 that repair work estimated to cost approximately \$1,500,000 is required to ensure safety and  
25 minimize impact of the airfield operation; and

1           WHEREAS, Pursuant to Administrative Code, Section 6.60(d), the Airport Director has  
2 secured the written approval of the President of the Airport Commission prior to authorizing  
3 the commencement of emergency work as the estimated cost of the work is in excess  
4 of \$250,000, and

5           WHEREAS, The Airport anticipates executing an emergency contract with The Dutra  
6 Group for repairs of the seawall erosion at the end of Runways 19L and 19R; and

7           WHEREAS, The Controller has certified that funds are available for this emergency  
8 contract; now, therefore, be it

9           RESOLVED, That Board of Supervisors approves the emergency declaration for  
10 seawall erosion made by the Airport Director on September 6, 2016; and, be it

11           FURTHER RESOLVED, That within thirty (30) days of an emergency contract being full  
12 executed by all parties, the Airport shall provide a copy of the contract to the Clerk of the  
13 Board for inclusion into the official file.




