3 **Ordinance authorizing settlement of the lawsuit filed by Henry McKenzie against the**
4 **City and County of San Francisco for \$400,000; the lawsuit was filed on**
5 **November 24, 2018, in the United States District Court Northern District of California,**
6 **Case No. 4:18-cv-7141 DMR; entitled Henry McKenzie v. City and County of San**
7 **Francisco, et al.; the lawsuit involves an employment dispute.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Henry McKenzie v. City and County of
12 San Francisco, et al., United States District Court, Case No. 4:18-cv-7141 DMR, by the
13 payment of \$400,000. The lawsuit involves an employment dispute.

14 Section 2. The above-named action was filed in United States District Court Northern
15 District of California on November 24, 2018, and the following parties were named in the
16 lawsuit: Plaintiff: Henry McKenzie; Defendants: City and County of San Francisco, George
17 Gascon, Jerry Rodriguez, David Crew.


