21       WHEREAS, The Board of Supervisors of the City and County of San Francisco (“Board  
22 of Supervisors”), after careful study and consideration, has determined that there is a  
23 shortage of safe and sanitary housing within the City and County of San Francisco (“City”),  
24 particularly for low and moderate income persons, and that it is in the best interest of the  
25

1 residents of the City and in furtherance of the health, safety, and welfare of the public for the  
2 City to assist in the financing of multi-family rental housing units; and

3 WHEREAS, Acting under and pursuant to the powers reserved to the City under  
4 Sections 3, 5, and 7 of Article XI of the Constitution of the State of California and Sections  
5 1.101 and 9.107 of the Charter of the City and County of San Francisco, the City has enacted  
6 the City and County of San Francisco Residential Mortgage Revenue Bond Law ("City Law"),  
7 constituting Article I of Chapter 43 of the San Francisco Administrative Code, in order to  
8 establish a procedure for the authorization, issuance and sale of residential mortgage revenue  
9 bonds by the City for the purpose of providing funds to encourage the availability of adequate  
10 housing and home finance for persons and families of low or moderate income, and to  
11 develop viable communities by providing decent housing, enhanced living environments, and  
12 increased economic opportunities for persons and families of low or moderate income; and

13 WHEREAS, In addition, pursuant to Division 31 of the Health and Safety Code of the  
14 State of California, and particularly Chapter 7 of Part 5 thereof ("State Law"), the City is  
15 empowered to issue and sell bonds for the purpose of making mortgage loans or otherwise  
16 providing funds to finance the development of multi-family rental housing including units for  
17 lower income households and very low income households; and

18 WHEREAS, Bernal Gateway Housing Associates, A California Limited Partnership (or  
19 any successor thereto including any successor owner of the Project, the "Developer"), desires  
20 to construct a 55-unit affordable residential rental housing development located at 3101  
21 Mission Street, 141 Precita Avenue, and 143 Precita Avenue, San Francisco, California 94110  
22 ("Project"); and

23 ///

1           WHEREAS, The Developer has requested that the City assist in the financing of the  
2 Project through the issuance of one or more series of tax-exempt mortgage revenue bonds  
3 (“Bonds”); and

4           WHEREAS, The City expects that proceeds of the Bonds will be used to pay certain  
5 costs incurred in connection with the Project prior to the date of issuance of the Bonds; and

6           WHEREAS, The City intends to issue the Bonds in an amount not to exceed  
7 \$35,000,000 and to loan the proceeds of the Bonds to the Developer (“Loan”) to finance the  
8 costs of the Project; and

9           WHEREAS, The Bonds will be limited obligations, payable solely from pledged  
10 security, including Project revenues, and will not constitute a debt of the City; and

11           WHEREAS, The Board of Supervisors has determined that the moneys advanced and  
12 to be advanced to pay certain expenditures of the Project are or will be available only for a  
13 temporary period and it is necessary to reimburse such expenditures with respect to the  
14 Project from the proceeds of the Bonds; and

15           WHEREAS, Section 1.150-2 of the United States Treasury Regulations requires that  
16 the Board of Supervisors declare its reasonable official intent to reimburse prior expenditures  
17 for the Project with proceeds of the Bonds; and

18           WHEREAS, The interest on the Bonds may qualify for tax exemption under Section  
19 103 of the Internal Revenue Code of 1986, as amended (“Code”), only if the Bonds are  
20 approved in accordance with Section 147(f) of the Code; and

21           WHEREAS, The City now wishes to approve the issuance of the Bonds in order to  
22 satisfy the public approval requirements of Section 147(f) of the Code; and

23           WHEREAS, The Project is located wholly within the City; and

24           WHEREAS, On May 27, 2018, the City caused a notice stating that a public hearing  
25 with respect to the issuance of the Bonds would be held by the Mayor’s Office of Housing and

1 Community Development on June 12, 2018, to appear in the San Francisco Examiner which  
2 is a newspaper of general circulation in the City; and

3 WHEREAS, The Mayor's Office of Housing and Community Development held the  
4 public hearing described above on June 12, 2018, and an opportunity was provided for  
5 persons to comment on the issuance of the Bonds and the Project; and

6 WHEREAS, This Board of Supervisors is the elected legislative body of the City and is  
7 the applicable elected representative authorized to approve the issuance of the Bonds within  
8 the meaning of Section 147(f) of the Code; and

9 WHEREAS, Section 146 of the Code limits the amount of tax-exempt private activity  
10 bonds, which include qualified mortgage bonds, that may be issued in any calendar year by  
11 entities within a state and authorizes the legislature of each state to provide the method of  
12 allocating authority to issue tax-exempt private activity bonds within the respective state; and

13 WHEREAS, Chapter 11.8 of Division 1 of Title 2 of the Government Code of the State  
14 of California governs the allocation in the State of California of the state ceiling established by  
15 Section 146 of the Code among governmental units in the State having the authority to issue  
16 tax-exempt private activity bonds; and

17 WHEREAS, Section 8869.85(b) of the Government Code requires that a local agency  
18 file an application for a portion of the state ceiling with or upon the direction of the California  
19 Debt Allocation Committee ("CDLAC") prior to the issuance of tax-exempt private activity  
20 bonds, including qualified mortgage bonds; and

21 WHEREAS, CDLAC procedures require an applicant for a portion of the state ceiling to  
22 certify to CDLAC that applicant has on deposit an amount equal to one-half of one percent  
23 (0.5%) of the amount of allocation requested not to exceed \$100,000; now, therefore, be it

24 RESOLVED, By the Board of Supervisors of the City and County of San Francisco, as  
25 follows:

1           Section 1. The Board of Supervisors finds and determines that the foregoing recitals  
2 are true and correct.

3           Section 2. The Board of Supervisors adopts this Resolution for purposes of  
4 establishing compliance with the requirements of Section 1.150-2 of the United States  
5 Treasury Regulations. This Resolution does not bind the Board of Supervisors to issue the  
6 Bonds, approve the Loan or to make any expenditure, incur any indebtedness or proceed with  
7 the Project.

8           Section 3. The Board of Supervisors hereby declares its official intent under United  
9 States Treasury Regulations Section 1.150-2 to use proceeds of the Bonds to reimburse  
10 expenditures incurred in connection with the Project. The Board of Supervisors hereby further  
11 declares its intent to use such proceeds to reimburse the Developer for actual expenditures  
12 made by the Developer on the Project.

13           Section 4. On the date of the expenditure to be reimbursed, all reimbursable costs of  
14 the Project will be of a type properly chargeable to a capital account under general federal  
15 income tax principles.

16           Section 5. The maximum principal amount of debt expected to be issued for the Project  
17 is \$35,000,000.

18           Section 6. This Board of Supervisors, as the applicable elected representative of the  
19 governmental unit having jurisdiction over the area in which the Project is located, hereby  
20 approves the issuance of the Bonds for purposes of Section 147(f) of the Code.

21           Section 7. This approval of the issuance of the Bonds by the City is neither an  
22 approval of the underlying credit issues of the proposed Project nor an approval of the  
23 financial structure of the Bonds.

24           Section 8. The Board of Supervisors hereby authorizes the Director of the Mayor's  
25 Office of Housing and Community Development, including any acting or interim director, or

1 such person's designee ("Director"), on behalf of the City, to submit an application  
2 ("Application"), and such other documents as may be required, to CDLAC pursuant to  
3 Government Code Section 8869.85 for an allocation for the Project of a portion of the state  
4 ceiling for private activity bonds in a principal amount not to exceed \$35,000,000.

5 Section 9. An amount equal to one-half of one percent (0.5%) of the amount of the  
6 CDLAC allocation requested for the Project, not to exceed \$100,000 ("Deposit"), is hereby  
7 authorized to be held on deposit in connection with the Application and the applicable CDLAC  
8 procedures, and the Director is authorized to certify to CDLAC that such funds are available.

9 Section 10. If the City receives a CDLAC allocation for the Project and the Bonds are  
10 not issued, the Mayor's Office of Housing and Community Development is hereby authorized  
11 to cause an amount equal to the Deposit to be paid to the State of California, if and to the  
12 extent required by CDLAC.


13 Section 11. The officers and employees of the City, including the Director, are hereby  
14 authorized and directed, jointly and severally, to do any and all things necessary or advisable  
15 to consummate the receipt of an allocation from CDLAC and otherwise effectuate the  
16 purposes of this Resolution, consistent with the documents cited herein and this Resolution,  
17 and all actions previously taken by such officers and employees with respect to the Project,  
18 consistent with the documents cited herein and this Resolution, including but not limited to the  
19 submission of the application to CDLAC, are hereby ratified and approved.

**Project Description**

*Bernal Gateway Apartments*

**Overview**

The funds described in the “Financing Structure” section below will be used to finance the acquisition and rehabilitation of Bernal Gateway Apartments, a 55-unit affordable multifamily housing project located at 3101 Mission Street and 141 & 143 Precita Avenue in the City and County of San Francisco (the “Project”).

Following rehabilitation, the Project will include approximately 66,312 square feet of gross floor area, comprised of 47,115 square feet of residential area and 19,197 square feet of non-residential area. Non-residential spaces will include a community center, a central office, and private storage.

Total project costs, including the cost to acquire the land and rehabilitate existing buildings, will be approximately \$40,713,141, or \$738,784 per dwelling unit.

The residential unit distribution, which will include one 3-bedroom manager’s unit is:

Twenty-seven percent of the Project’s residential units will serve households earning no more than 20 percent of the San Francisco County Area Median Income (“AMI”), twenty-five percent of units will serve households earning no more than 30 percent of AMI, and the balance of units will serve households earning no more than 60 percent of AMI.

**Residents**

No residents will be displaced as all residents will have the right to return after any temporary relocation that might be required.

- New trash/recycling metal fence enclosure at rear courtyard
- HVAC
  - Replace exhaust vent caps at building 1 roof
  - Replace mechanical equipment and re-zone systems (design-build)
- Plumbing
  - Replace heating and domestic hot water boilers
  - Repair/clean select sewer laterals, waste pipes
- Electrical
  - Replace building exterior/site lighting
  - Replace interior common area lighting at building 1
  - Replace lighting at unit porches & balconies at buildings 2 & 3
- Accessibility
  - Add new accessible mobility features at 3 existing units
  - Add new accessible communications features at 1 existing unit

### **Financing Structure**

The following sources of capital financing are expected to be utilized:

- tax-exempt bonds issued by the City;
- 4% low income housing tax credits (“LIHTC”);
- seller carryback financing from Bernal Heights Housing Corp; and
- a conventional first mortgage.

The sale of LIHTC will generate equity financing for the Project. The amount of private activity tax-exempt bonds used during construction will be sized specifically to meet the 50% of aggregate basis test required for the LIHTC.

### **Schedule**

Financing is anticipated to close between January and February 2019, with construction commencing within 60 days of closing. All construction is scheduled to be completed by June 2020.

Tenants are expected to be temporarily relocated for approximately two weeks during each phase of the rehabilitation.

NOTICE IS HEREBY GIVEN that on Tuesday, June 12, 2018, at 10:00 a.m., in the Mayor's Office of Housing and Community Development, 1 South Van Ness Avenue, 5<sup>th</sup> Floor, San Francisco, CA 94103, the City and County of San Francisco (the "City") will conduct a public hearing (the "Public Hearing") at which time the City will hear and consider information concerning the proposed sale and issuance by the City of multifamily affordable housing mortgage revenue bonds (the "Bonds") in an aggregate principal amount not to exceed thirty-five million (\$35,000,000).
