3 Resolution authorizing the Department of the Environment to accept and expend grant  
4 funds in the amount of \$10,000 from the AAA Greenlight Initiative for the purpose of  
5 developing, producing and disseminating a brochure on clean air vehicles in English,  
6 Spanish and Chinese.

8 WHEREAS, After a competitive process the Clean Air Program of the Department of  
9 the Environment for the City and County of San Francisco (SF Environment) was awarded  
10 grant funding from the AAA Greenlight Initiative; and,

11 WHEREAS, The Board of Supervisors for the City and County of San Francisco  
12 enacted the "Healthy Air And Smog Prevention" Ordinance in 1999 to reduce emissions from  
13 the City's fleet vehicles in an effort to promote clean air and to protect public health; and,

14 WHEREAS, The Board of Supervisors for the City and County of San Francisco  
15 adopted the Sustainability Plan for the City and County of San Francisco which states that  
16 "[a]chieving and maintaining good air quality is crucial to the public health and economic  
17 vitality of San Francisco" ; and,

18 WHEREAS, Passenger vehicles account for 40% of California's global warming  
19 emissions; and,

20 WHEREAS, If residents of San Francisco choose clean air vehicles over more polluting  
21 vehicles it will mitigate the City's pollution and global warming emissions; and,

22 WHEREAS, The primary objective of the trilingual brochure is to educate the public  
23 about clean vehicle technologies, purchase options, available incentives and to raise  
24 awareness about the linkages between vehicle emissions, climate change and public health;


1 WHEREAS, Funds from this grant will be used to support SF Environment's Clean Air  
2 Program in performing actions in keeping with the City's environmental goals; and,  
3 WHEREAS, The grant budget includes \$1,000 for indirect costs; and,  
4 WHEREAS, This grant does not require an ASO amendment; now, therefore, be it  
5 RESOLVED, That the Director of the Department of the Environment is authorized to  
6 accept and expend \$10,000 funding from the AAA Greenlight Initiative.
