3 Resolution authorizing the Department on the Status of Women to accept <sup>retroactively</sup> and expend a  
4 grant in the amount of \$145,475 from The California Endowment for establishing San  
5 Francisco's first Centralized Twenty-Four-Hour Multi-Language Domestic Violence  
6 Crisis Line.

8 WHEREAS, The development of a consolidated multi-language domestic violence  
9 crisis line will create a solid infrastructure in San Francisco; and,

10 WHEREAS, The line will be designed to protect abused women from serious injury and  
11 death; and,

12 WHEREAS, The line will enable San Francisco to access the most innovative domestic  
13 violence crisis line services in the United States; and,

14 WHEREAS, This community-based project will be a partnership with current crisis line  
15 providers and other community organizations; and,

16 WHEREAS, A centralized, multi-language domestic violence crisis line would increase  
17 access, reduce duplication of services, preserve resources, and best serve women and girls  
18 in San Francisco; and,

19 WHEREAS, The agency will conduct an extensive recruitment of multicultural, multi-  
20 lingual staff, and a comprehensive staff training process which meets State standard and  
21 address local community issues; and,

22 WHEREAS, The crisis line will provide comprehensive, accessible, uninterrupted  
23 services to public every day throughout the year, including crisis intervention and counseling  
24 and referrals for survivors, their friends and families; and,




7 RESOLVED, That the Board of Supervisors hereby authorized the Director of the
