

WHEREAS, over this four-year period, the Department of Aging and Adult Services will implement strategic system improvements to create a coordinated model of community-based long term care and supportive services for vulnerable older adults; and,

WHEREAS, the grant budget for FY 2003-04 amounts to \$112,869, and the grant budget includes provision for indirect costs of \$5,669, now, therefore, be it

RESOLVED, That the Board of Supervisors authorizes the Department of Aging and Adult Services to accept and expend funds from the Robert Wood Johnson Foundation in the amount of \$112,869.




