so, does the department pass the related costs onto the permit applicant? If not, are there standards in place for signs and sign holders which are not City issued?

8. What are the penalties in place for persons who operate a white zone without a permit?

9. Please provide any written materials the Department has regarding white parking zones including the application form.

Further requesting that the San Francisco Police Department respond within 30 days.
