Contract No. 10401.46 Capital Program Support Services for the Capital Improvement Plan

This Modification is made this 1st day of September 2025 in the City and County of San Francisco, State of California, by and between T.Y. Lin International, 345 California Street, Suite 2300, San Francisco, CA 94104 (the "Contractor") and the City and County of San Francisco, a municipal corporation (the "City"), acting by and through its Airport Commission (the "Commission").

Recitals

- A. The Commission wishes to enter into an Agreement for Capital Program Support Services for the Capital Improvement Plan for the San Francisco International Airport (the "Airport"); and
- B. The Commission is authorized to enter into all contracts which relate to matters under its jurisdiction; and
- C. On August 20, 2024, by Resolution No. 24-0173, the Commission awarded this Agreement to the Contractor for a one-year term with a not-to-exceed amount of \$8,000,000 and options to extend the term for up to five years; and
- D. On November 16, 2024, City and Contractor administratively modified the Agreement to update standard contractual clauses, update overhead rates, add Allele Network, Futterman Consulting, Inc., and Modulus Consulting to the list of approved subcontractors through Modification No.1; and
- E. On March 4, 2025, by Resolution No. 25-0035, the Commission approved Modification No. 2, increasing the contract amount by \$32,000,000 for a new total contract amount not to exceed \$40,000,000, exercising all options to extend the term of the Agreement for services through September 29, 2029, and directing the Director of Commission Affairs to seek Board of Supervisors approval of Modification No. 2 consistent with San Francisco Charter Section 9.118(b); and
- F. On (MONTH and DATE) by Resolution No. [] the Board of Supervisors approved this Modification No. 2 under San Francisco Charter Section 9.118(b), authorizing an increase to the contract not-to-exceed amount of \$32,000,000 for a new total not-to-exceed amount of \$40,000,000; and
- G. City and Contractor desire to modify the Agreement on the terms and conditions set forth herein to increase the contract not-to-exceed amount and extend the term of the Agreement; and
- H. Approval for this Agreement was obtained when the Civil Service Commission approved PSC No. 40890-14/15
- I. Contractor represents and warrants that it is qualified to perform the services required by City under this Agreement.

NOW, THEREFORE, Contractor and City agree as follows:

- 1. **Article 1.1 Agreement** is replaced as follows:
- 1.1 "Agreement" means the contract document dated August 20, 2024, and Modification No.1 dated November 16, 2024, including all attached appendices and all applicable city ordinances and "Mandatory City Requirements," which are specifically incorporated by reference into the Agreement.
- 2. **Article 2 Term of the Agreement** is hereby replaced in its entirety with a new **Article 2 Term** to read as follows:
- 2.1 The term of this Agreement commenced on **September 30, 2024**, and will expire on **September 29, 2029**, unless earlier terminated as otherwise provided in this Agreement.
- 3. Article 3. Financial Matters, 3.3. Compensation, Section 3.3.1 Calculation of Charges is hereby amended to increase the Agreement's total maximum compensation payable by Thirty-Two Million Dollars (\$32,000,000) for a new total not-to-exceed amount of Forty Million Dollars (\$40,000,000).
- 4. **Effective Date.** Each of the changes set forth in this Modification shall be effective on and after the date of this Modification.
- 5. **Legal Effect.** Except as expressly changed by this Modification, all of the terms and conditions of the Agreement shall remain unchanged and in full force and effect.
