

1 [Accept and Expend Grant - Retroactive - California Department of Public Health - Fentanyl
2 Overdose Prevention Grant - \$1,281,000]

3 **Resolution retroactively authorizing the Department of Public Health to accept and**
4 **expend a grant in the amount of \$1,281,000 from the California Department of Public**
5 **Health for participation in a program, entitled “Fentanyl Overdose Prevention Grant,”**
6 **for the period of March 1, 2024, through February 28, 2027.**

8 WHEREAS, The California Department of Public Health (CDPH) has agreed to fund
9 the San Francisco Department of Public Health (DPH) in the amount of \$1,281,000 for the
10 period of March 1, 2024, through February 28, 2027; and

11 WHEREAS, Through the Fentanyl Overdose Prevention Grant, the DPH Office of
12 Overdose Prevention will implement an innovative program entitled Advancing Racial Equity
13 and Data-Driven Responses (AREDDR); and

14 WHEREAS, Through the AREDDR program, DPH will take a multi-pronged approach
15 to addressing racial disparities in overdose-related fatalities; and

16 WHEREAS, DPH will contract with the San Francisco African American Faith-Based
17 Coalition to implement a peer-led navigation program for existing clients receiving medication
18 for opioid use disorder (MOUD) services and expanding access to and knowledge of MOUD,
19 with a particular focus on the over-burdened Black/African American community in San
20 Francisco; and

21 WHEREAS, DPH will also work to strengthen its existing partnership and knowledge
22 sharing with the Office of the Chief Medical Examiner (OCME) to improve data-driven, equity-
23 focused, real-time overdose response interventions; and

24 WHEREAS, The grant does not require an Annual Salary Ordinance Amendment; and

1 WHEREAS, A request for retroactive approval is being sought because DPH received
2 the award letter on December 8, 2023, for a project start date of March 1, 2024; and

3 WHEREAS, The Department proposes to maximize use of available grant funds on
4 program expenditures by not including indirect costs in the grant budget; now, therefore, be it

5 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in
6 the grant budget; and, be it

7 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
8 expend a grant in the amount of \$1,281,000 from the CDPH; and, be it

9 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
10 expend the grant funds pursuant to Administrative Code, Section 10.170-1.
