8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. The City Attorney is hereby authorized to settle the action entitled Fleming
10 v. City and County of San Francisco, San Francisco Superior Court of California, Case No.
11 CGC 10-501543, by the payment of \$70,000.00, and the City's agreement that plaintiff
12 Damian Fleming will earn a Step 5 salary in his gardener (3417) position at the Department of
13 Public Works, as well as pursuant to the other terms as set forth in the Settlement Agreement.

15 Section 2. The above-named action was filed in San Francisco Superior Court of
16 California on July 14, 2010, and the following parties were named in the lawsuit: Damian
17 Fleming, plaintiff; City and County of San Francisco, and Does 1 through 10, inclusive,
18 defendants.
