7 Be it ordained by the People of the City and County of San Francisco:

8 Section 1: The City Attorney is hereby authorized to settle the action entitled Erik

10 Northern District of California, Court No. 12-CV-00929 JCS by the payment of \$30,000.

11 Section 2. The above-named action was filed in United States District Court, Northern
12 District of California on February 24, 2012, and the following parties were named in the
13 lawsuit: Erik Russell, plaintiff, City and County of San Francisco, San Francisco Police
14 Department, Greg Suhr, in his capacity as Chief of Police of the City and County of San
15 Francisco, Damien Reyes, individually and in his capacity as a Peace Officer for the City and
16 County of San Francisco, and Does 1 – 200, jointly and severally, defendants.
