2 AMENDING RESOLUTION NUMBER 549-00 TO AUTHORIZE THE COMMISSION ON
3 THE AGING TO ACCEPT RETROACTIVELY AND EXPEND A GRANT IN THE AMOUNT
4 OF \$403,192 FROM THE STATE OF CALIFORNIA DEPARTMENT OF COMMUNITY
5 SERVICES AND DEVELOPMENT FOR A NATURALIZATION SERVICES PROGRAM
6 BEGINNING MAY 1, 2000 AND ENDING SEPTEMBER 30, 2001.

8 WHEREAS, Resolution number 549-00 of the Board of Supervisors authorized the
9 Commission on the Aging (COA) to accept and expend a grant from the State of California
10 Department of Community Services and Development in the amount of \$201,696 to fund
11 the Naturalization Services Program from May 1, 2000 through June 30, 2001, and;

13 WHEREAS, This program is providing naturalization services including outreach,
14 intake and assessment, citizenship preparation, advocacy, and follow up through contracts
15 with community based nonprofit organizations, and;

17 WHEREAS, The State of California wishes to double the amount of the original grant
18 from \$201,696 to \$403,192 and extend its term until September 30, 2001 in an effort to
19 provide coordination and accountability to the naturalization effort, and;



21 WHEREAS, The entire amount of these funds will be used for direct service contracts
22 without indirect costs; now, therefore, be it

24 RESOLVED, That the Board of Supervisors amends Resolution number 549-00 to
25 authorize the retroactive acceptance and expenditure of funds from the California
Department of Community Services and Development by the Commission on the Aging in

the amount of \$403,192 to fund the Naturalization Services Program from May 1, 2000 until September 30, 2001; and, be it


