WHEREAS, The District Attorney and the City and County of San Francisco desires to renew its current contract with the Victim Compensation and Government Claims Board to provide a means to pay for verified funeral/burial expenses and emergency relocation for victims of domestic violence and sexual assault, and be reimbursed by the State thereafter; and,

WHEREAS, This contract would authorize the District Attorney's Victim Witness Assistance Program to pay verified funeral/burial expenses and emergency relocation for victims of domestic violence and sexual assault out of the revolving funeral/burial fund; and,

WHEREAS, The fund maintains a process by which the District Attorney may make speedy payments to service providers and increase services to victims; now, therefore, be it

RESOLVED, That the Board of Supervisors hereby authorizes the District Attorney of the City and County of San Francisco to renew the contract with the California Victim Compensation and Government Claims Board; and be it

FURTHER RESOLVED, That the District Attorney is authorized to execute on behalf of the City and County of San Francisco the necessary revolving fund agreements with the Victim Compensation and Government Claims Board for purposes including any extensions, augmentations or amendments thereof; and be it

Supervisor Dufty District Attorney BOARD OF SUPERVISORS FURTHER RESOLVED, That the District Attorney is authorized to sign and submit claims to the Victim Compensation and Government Claims Board for reimbursement of funds expended for verified funeral/burial expenses and emergency relocation for victims of domestic violence and sexual assault; and be it

FURTHER RESOLVED, That the State funds received hereunder shall not be used to supplant local funds that would, in the absence of the agreement, be made available to support assistance to victims of crime.
