2 AUTHORIZING THE RECREATION AND PARK DEPARTMENT TO ACCEPT AND EXPEND
3 \$65,000 GRANT FROM THE NATIONAL RECREATIONAL TRAILS FUND ACT OF 1991
4 RECEIVED DURING FISCAL YEAR 1996-97 FOR RENOVATION OF TRAILS ON
5 STRAWBERRY HILL IN STOW LAKE, GOLDEN GATE PARK.

7 WHEREAS, The National Recreational Trails Fund Act of 1991
8 provides funds to the State of California for grants to state, local
9 and non-profit organizations to acquire, develop and/or maintain
10 motorized and non-motorized trails; and,

11 WHEREAS, Resolution 738-96 approved by the Board of Supervisors
12 on August 21, 1996 authorized the Recreation and Park Department to
13 apply for funds from the National Recreational Trails Fund Act of
14 1991; and,

15 WHEREAS, The Department was awarded a grant in the amount of
16 \$65,000 and will enter into an agreement with the State of California
17 to complete the project; and

18 WHEREAS, Indirect costs are not allowed by the funder; now,
19 therefore, be it

20 RESOLVED, That the City and County of San Francisco Board of
21 Supervisors hereby;

- 22 1. Approves the acceptance and expenditure of \$65,000 for renovation
23 of trails on Strawberry Hill in Stow Lake, Golden Gate Park;




