He would be a great asset to the Veteran Affairs Commission and to the City and County of San Francisco.



VA hospital expansion runs into roadblocks

Richmond residents concerned about plans for medical center

Officials at the 75-year-old, I millionsquare-foot veterans hospital in the northwest corner of the Outer Richmond district are weighing expansion plans, but must confront concerns from residents about parking.

The San Francisco Veterans Affairs Medical Center, a hospital and research center at Fort Miley at 45th Avenue and Clement Street, serves 55,000 patients who have made about 400,000 visits to the aging structures in the past year alone

An expansion during the next 20 years would accommodate a growing number of patients, about 2,000 employees and the approximately 700 UC San Francisco students who do research and reside there annually, according to the U.S. Department of Veterans Affairs.

"The facility as it is now certainly limits our opportunity to expand and grow to new programs. We're the No. 1 research program in the entire [Veterans Affairs Department] system," VA spokeswoman Judi Cheary said. "We have patients come from all over the country for some of our programs."

But the expansion, on a site that

already lacks 700 parking spaces, will have incredible impacts on neighbors, according to members of the Planning Association for the Richmond, a neighborhood group.

"They are good neighbors for purposes of treating veterans," association member Jason Jungreis said of the medical center. "But it's really already stressed to the limit and they are already having tremendous problems with sustainability."

Cars from all around Northern California already circle the streets for parking that would normally be used by permitted residents, Jungreis said.

In 2006, the association and other neighborhood groups, such as Friends of Lands End, filed a civil suit against the VA because of plans to build a 200,000-square-foot research facility without performing an environmental review.

That suit argued that under that plan, by 2012 the VA would need more than 900 parking spaces to meet demand.

As a result of the legal action, the VA is now required to create an environmental impact statement for its 20-year institutional master plan and seek public comment on three expansion options — to build entirely on-site, build some on- and some off-site or to choose an entirely new location.

The VA is holding a public meeting for comments at 6 p.m. Oct. 26 in its auditorium.



Greetings,

My name is Brendan Rogers; I respectfully request to serve as a Veterans Affairs Commissioner. Please excuse my absence at this hearing, which I strongly desired to attend. Currently I am deployed overseas with the US Coast Guard Reserve.

I grew up in San Francisco, in the Mission and Excelsior districts. As a young adult I became homeless, and enlisted to escape my extreme poverty. My service has taken me all over the world, allowed me to obtain my degree, and in 13 years (10 active, 3 reserves) I have risen from the very lowest rank to that of Chief Maritime Enforcement Specialist (E-7).

As a senior enlisted person, I have had first hand experience with troops who have suffered from PTSD, addiction, suicide, and have been victims of discriminatory policy against LGBT servemembers. San Francisco is often portrayed to be a place that is unsupportive of the Military, but this could not be further from the truth. The effects of war last long after the last shot is fired. San Francisco is the place where people go when the places that they are from, cannot or will not address their needs. As the wars overseas wind down, our city will see a surge of both veterans seeking services and accessing our educational institutions through the GI Bill.





I would like to comment on **Mr. Matt Shea**, Commander, American Legion Post 911 and former officer, **American Legion War Memorial Commission** (ALWMC).

As I have been told, Mr. Shea served in our Army and served multiple tours either in Iraq or Afghanistan. I salute him for his service to America.

I have known Mr. Shea the past 3-4 years while he served in the ALWMC and Post 911. His performance in both these positions was marginal and his handling of the finances of both organizations was questionable. He received pay for his volunteer service in the ALWMC and countersigned checks to pay another American Legion volunteer. This is not appropriate (not necessarily illegal) for a volunteer in the American Legion. These payments were not authorized by officers in the ALWMC. By definition volunteers are paid staff. Funding for the ALWMC is primarily from funds granted by our City's Board of Trustees.

Mr. Shea appears to have been unemployed for an extended period of time and that is regrettable, however, he should not have received pay for his volunteer work, and there is no documentation detailing what he did to earn his pay.

Like other combat veterans, he may be a victim of PTSD, and that too is regrettable. I do not know whether he is being treated by doctors for combat stress (PTSD).

I do not harbor ill will toward Mr. Shea, but report facts related to his lackluster service to the American Legion the past few years for your consideration.

It is my understanding that at your Rules Committee meeting on Thursday, March 17, you will be reviewing and making recommendations for the appointment a number of individuals to the Veterans Affairs Commission. I know several of the incumbents and support their reappointment to the VAC.

However, one of the veterans who is seeking a first time seating on the VAC is not, in my opinion, a good candidate. I have known Mr. Matt Shea for about 3 years in his capacity first as a member, then Finance Officer, then Commander of American Legion Post 911 in San Francisco.

It is unfortunate that Mr. Shea may be the only young veteran on your list of candidates, because the VAC could certainly benefit from new energy and insights. However, while the VAC certainly needs qualified younger veterans, Mr. Shea has not exhibited the qualities of character and cooperation within the American Legion that would indicate he is qualified for such an appointment.

When Mr. Shea came into Post 911—the first post in the American Legion specifically for veterans of the wars in Iraq and Afghanistan—he was welcomed with open arms by the other American Legion posts in San Francisco, and by Legionnaires across the state. However, throughout his association with the American Legion, he has proven himself to be divisive, uncooperative and hostile towards many of those who welcomed him. Why this is, I cannot say, because I do not know what his experiences were prior to leaving the military, nor do I know what is in his heart. However, he has proven himself unable or unwilling to work in a cooperative manner with his comrades within the American Legion, and there is no reason to believe that he would behave any better within the VAC.

I would be glad to fill you in on specifics of his behavior if you care to hear them, but do not want to bother you with unnecessary and convoluted details. I hope it will be sufficient to say that after three frustrating years of association with him, and after many heartfelt attempts by a very large number of our members to work with him, the American Legion District Eight (governing body of all the posts in San Francisco) was forced to try him in accordance with our bylaws on February 10. Mr. Shea was formally charged with five counts of conduct unbecoming a Legionnaire; he

was convicted on three of them and issued letters of reprimand. In addition, later that same week at the regular meeting of the District 8, his Post—of which he is and has been the Commander for nearly two years—was put on suspension. Subsequently, both the personal reprimands and the post's suspension were confirmed at the state-level Department Executive Committee meeting. At this time, his post's bank account and membership lists have been seized and the post is not allowed to conduct business until its books, leadership structure, and fundraising activities can be scrutinized and corrected. These actions are all the direct result of Matt Shea's failure of leadership, incompetence, and inability or refusal to cooperate with those of us who wanted him to succeed.

Now that he has burned all of the many bridges within the American Legion, it appears that he has set his sights on the Veterans Affairs Commission. I tell you sadly but sincerely, it would be a mistake for the City to appoint him to that position.

Board Qualifications:

The Veterans Affairs Commission consists of a total of seventeen members, twelve of whom are appointed by the Board of Supervisors and five of whom are appointed by the Mayor as follows: Of the seventeen members, at least three must be women veterans (at least 2 members shall be appointed by the Board) and two members who served in the Armed Forces of the United States and who have a physical disability arising from that service (the Mayor and Board of Supervisors shall each appoint at least one member), in accordance with the definitions applied in such cases by the Veterans' Administration. All members shall reside in the City and County of San Francisco. The Board of Supervisors may only waive this requirement by ordinance.

The term of each member of the Commission shall be four years, provided, however, that the members first appointed shall, by lot, classify their terms so that three members shall serve a one-year term, four members shall serve a two-year term, four members shall serve a three-year term and four members shall serve a four-year term. On the expiration of these and successive terms, their successors shall be appointed for a four-year term in a manner similar to that described for the initial members. In the event a vacancy occurs during the term of office of any member, a successor shall be appointed for the unexpired portion of the term of the office vacated in a manner similar to that described for the initial members.

The Commission shall advise directly the Mayor and the Board of Supervisors on all matters affecting veterans of the Armed Forces of the United States of American, on the problems,

interests and needs of veterans who are residents of the City and County of San Francisco and on the coordination of economic development, health care, and social services programs as they relate to veterans who are residents of the City and County of San Francisco.
