WHEREAS, At least two of the directors must possess significant knowledge of, or professional experience in, the field of public transportation; and,

WHEREAS, The Mayor has appointed Shirley Breyer Black to the Board of Directors of the Municipal Transportation Agency for a term commencing March 1, 2000 and ending March 1, 2002; now, therefore, be it
