

1 [Resolution approving the Agreement between Informatix, Inc. and City for computer  
2 consulting services necessary to implement the Computer Assisted Support Enforcement  
3 System (CASES) Consortium for thirty-four California counties, including San Francisco.]

4 **Resolution retroactively approving the Agreement and its subsequent amendment  
5 between Informatix, Inc. and City, dated May 3, 2000, for computer consulting services  
6 **necessary to implement the CASES Consortium.****

7 WHEREAS, San Francisco developed the Computer Assisted Support Enforcement  
8 System (CASES) for managing child support caseloads, and tracking child support payments  
9 and child support actions at the County level and CASES has operated in San Francisco and  
10 five other counties for over ten years; and,

11 WHEREAS, the California Department of Child Support Services (CDCSS) directed  
12 twenty-eight other California counties to convert to CASES as an interim system of managing  
13 child support caseloads pending development of a statewide system; and,

14 WHEREAS, CDCSS appointed San Francisco as the lead county in the thirty-four  
15 county CASES Consortium; and

16 WHEREAS, The Family Support Bureau of the District Attorney's Office, after a  
17 competitive procurement process, selected Informatix, Inc, a Local Business Enterprise (LBE)  
18 and a Minority Business Enterprise (MBE) registered with the Human Rights Commission, to  
19 provide the computer consulting services necessary to convert the twenty-eight counties to  
20 CASES and to maintain the system for the thirty-four counties operating on CASES thereafter;  
21 and,

22 WHEREAS, The federal and state governments, through the CDCSS, provides all  
23 funding for the consulting services provided by Informatix, Inc.; and,

24 WHEREAS, The Family Support Bureau of the District Attorney's Office entered into an  
25 Agreement with Informatix, Inc. on May 3, 2000 for \$30,135,820 to provide such consulting

1 services, subject to the budget and fiscal provisions of the City's Charter, which Agreement  
2 was approved by both the federal and state child support agencies; and,

3 WHEREAS, The City Department of Child Support Services, the successor to the  
4 Family Support Bureau of the District Attorney's Office, has not yet expended ten million  
5 dollars pursuant to this Agreement, but anticipates doing so in fiscal year 2001/2002; and,

6 WHEREAS, Pursuant to San Francisco Charter Section 9.118, the Agreement between  
7 Informatix, Inc. and City requires Board of Supervisors approval; and,

8 WHEREAS, The City's Department of Child Support Services has submitted the  
9 Agreement between Informatix, Inc. and City for approval, which Agreement is on file with the  
10 Clerk of the Board of Supervisors in File No. 011671, which is hereby declared to be part of  
11 the resolution as if set forth fully herein; now, therefore, be it

12 RESOLVED, That the Board of Supervisors hereby retroactively approves the  
13 Agreement and its subsequent amendment between Informatix, Inc. and City, dated May 3,  
14 2000, for computer consulting services, and ratifies all previous action taken.
