Hearing to consider that the premise-to-premise transfer of a Type-21 off-sale general beer, wine, and distilled spirits liquor license to Gus's Market Channel, LLC, doing business as Gus's Community Market, located at 1101-4th Street (District 6), will serve the public convenience or necessity of the City and County of San Francisco. Retail sale of beer, wine, and distilled spirits is permitted at 1101 Fourth Street by the Mission Bay South Redevelopment Plan, which serves as a land use legislation controlling zoning for the Mission Bay South Redevelopment Area.

- 1) Sales, service, and consumption of alcoholic beverages shall be permitted only between the hours of 7:00 a.m. and 12:00 a.m. (midnight) each day of the week;
- 2) Petitioner(s) shall actively monitor the area under their control in an effort to prevent the loitering of persons on any property adjacent to the licensed premises as depicted on the most-recently certified ABC-253;
- 3) No noise shall be audible at any nearby residence or consideration point; and
- 4) No wine shall be sold in bottles or containers small than 375 milliliters.
