16 WHEREAS, The San Francisco Recreation and Park Commission adopted a  
17 resolution recommending that the Board of Supervisors to accept and expend a gift in the  
18 amount of \$11,750 from the Levi Strauss Foundation to be used to support recreation  
19 programs and gardening activities at the parks and recreation centers listed; therefore be it

20 **RESOLVED**, That the Board of Supervisors authorizes the General Manager of the


