Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Fidelia del Carmen May Can, et al. v. City and County of San Francisco, et al.</u>, United States District Court, Case No. 16-cv-05771 by the payment of \$140,000. The lawsuit involves alleged civil rights violations.
