3 **Ordinance adopting regulation of vending within the jurisdiction of the Port of San**
4 **Francisco, requiring permits, and authorizing permit fee and enforcement actions in the**
5 **Port Code; requiring the Port and the Department of Public Health to report to the**
6 **Board of Supervisors about regulatory implementation and health and safety**
7 **enforcement; amending provisions of the Port Code and repealing peddler regulations**
8 **in the Police Code to comply with state law regarding sidewalk vending; amending**
9 **provisions of the Administrative, Business and Tax Regulations, Health, and**
10 **Transportation Codes to conform with state law and new Port Code regulations**
11 **regarding vending; and adopting findings under the California Environmental Quality**
12 **Act.**

18 Be it ordained by the People of the City and County of San Francisco

19 Section 1. Environmental Findings.

20 The Planning Department has determined that the actions contemplated in this
21 ordinance comply with the California Environmental Quality Act (California Public Resources
22 Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of
23 Supervisors in File No. 210566 and is incorporated herein by reference.

1 Section 2. General Findings.

2 (a) The Port of San Francisco (“Port”) manages the waterfront as the gateway to a
3 world-class city, and advances environmentally and financially sustainable maritime,
4 recreational, and economic opportunities to serve the City and County of San Francisco
5 (“City”), the Bay Area, and California.

6 (b) The Port is home to many of San Francisco’s leading visitor destinations, and
7 welcomed over 24 million visitors annually before the COVID-19 pandemic.

8 (c) In furtherance of the City’s recovery from the pandemic, the Port is committed to
9 supporting the growth of waterfront jobs and providing space for new and expanding
10 businesses on Port property, while maintaining public health and safety as well as scenic and
11 recreational opportunities.

12 (d) Vending, because it has a relatively low barrier to entry, encourages
13 entrepreneurship, represents a significant sector of San Francisco’s local economy, and
14 provides economic opportunity for people to support themselves and their families, which is a
15 City priority.

16 (e) A well-regulated vending program would ensure the Port’s streetscape can
17 remain a vibrant and dynamic marketplace, with unparalleled historic, scenic, and recreational
18 value that can be safely enjoyed by all. Regulations are needed for several reasons: to
19 accommodate vending, including vendors’ equipment, while safeguarding pedestrian and
20 chair-user movement on sidewalks, streets, and other public spaces; to prevent unsanitary
21 conditions and ensure trash and debris are removed by vendors; and to protect the scenic
22 and natural character of the Port of San Francisco’s parks and waterfront, and the recreational
23 opportunities the areas provide.

24 (f) In 2018, then-Governor Jerry Brown signed Senate Bill 946 (“SB 946”), which
25 decriminalized street vending across California and constrained local regulatory authority. SB

1 946 seeks to create entrepreneurial and economic development opportunities for immigrant
2 and low-income communities, increase access to desired goods, contribute to a safe and
3 dynamic public space, and promote the safety and welfare of the public by encouraging local
4 authorities to support and properly regulate vending.

5 (g) The Board of Supervisors (“Board”) seeks to prioritize health and safety, protect
6 the scenic and natural character of our City’s parks and open spaces, and the waterfront,
7 while expanding economic opportunities for those who aspire to vend lawfully in a manner
8 consistent with SB 946. The Board recognizes that regulation of vending benefits the City as
9 a whole, as it leads to orderly commerce and safeguards public health. The Board seeks to
10 provide vendors with the ability to operate in a safe, professional, and meaningfully
11 enforceable manner that enhances the visitor experience at the waterfront and provides
12 increased economic opportunities; and

13 (h) The Board seeks to create a vending program which provides permitting and
14 regulation of street vendors on Port property.

15
16 Section 3. The Port Code is hereby amended by adding Article 2A, to read as follows:

17 **ARTICLE 2A: PERMIT REGULATIONS FOR MOBILE VENDORS**

18 **SEC. 2A.1. DEFINITIONS.**

19 *For the purpose of this Article 2A, the following words and phrases have the following*
20 *meanings:*

21 **Administrative Citation.** *An administrative fine for a violation of this Article 2A, as described*
22 *in Section 2A.8(b).*

23 **Certified Farmers’ Market.** *A farmers’ market operated in accordance with Health Code*
24 *Section 440(d) and with Chapter 10.5 (commencing with section 47000) of Division 17 of the*
25 *California Food and Agricultural Code, as each may be amended, and any implementing regulations.*

1 **City.** *The City and County of San Francisco.*

2 **Department.** *The Port.*

3 **Director.** *The Executive Director of the Port, or the Executive Director’s designee.*

4 **Enforcement Official.** *Officers, employees, and contractors of the Port, and of such other*
5 *departments and agencies of the City, as designated by the Director.*

6 **Food.** *Any food, foodstuffs, or beverage for human consumption, and is inclusive of the*
7 *definitions of “Food” in Health Code Section 440(b) and in California Health and Safety Code section*
8 *113781, as each may be amended.*

9 **Merchandise.** *Any item that is not Food and that is not an art or craft regulated under Article*
10 *24 (Regulating Street Artists) of the Police Code.*

11 **Mobile Vendor.** *A person or entity that Vends Food or Merchandise from a pushcart, pedal-*
12 *driven cart, wagon, or other nonmotorized conveyance, or from one’s person or a stand, display,*
13 *showcase, table, rack, or other movable structure. The term Mobile Vendor is comprised of each*
14 *Roaming Mobile Vendor and each Stationary Mobile Vendor, and includes but is not limited to a*
15 *Sidewalk Vendor as defined in California Government Code section 51036, as it may be amended from*
16 *time to time. If a Mobile Vendor Vends as an employee or agent of another person or entity, that*
17 *person or entity is also a Mobile Vendor.*

18 **Port.** *The Port of the City and County of San Francisco. Also, designated as the Department.*

19 **Roaming Mobile Vendor.** *A Mobile Vendor that moves from place to place and stops*
20 *intermittently to complete a Vending transaction.*

21 **Rules and Regulations.** *The Rules and Regulations of Mobile Vendors as described in Section*
22 *2A.5 of this Article.*

23 **Stationary Mobile Vendor.** *A Mobile Vendor that Vends from one or more fixed locations.*

1 **Swap Meet.** A swap meet operated in accordance with Article 6 (commencing with section
2 21660) of Chapter 9 of Division 8 of the California Business and Professions Code, as it may be
3 amended, and any regulations adopted in accordance with that chapter.

4 **Vend (and variations such as Vends, Vending).** To sell, offer for sale, expose or display for
5 sale, solicit offers to purchase, or barter Food or Merchandise. Vending includes offering free samples
6 of Food or Merchandise that are also for sale, or negotiating fees for Food or Merchandise.

7 **SEC. 2A.2. PERMIT REQUIRED; MANDATORY DISPLAY.**

8 (a) No person may Vend on any property within the regulatory jurisdiction of the Port,
9 including a public right-of-way (as that term is defined in Public Works Code Section 2.4.4) or any
10 other street, sidewalk, alley, walkway, or pedestrian path available to the public, without first having
11 obtained either a Roaming Mobile Vendor permit or a Stationary Mobile Vendor permit pursuant to
12 this Article 2A.

13 (b) A Mobile Vendor shall prominently display a Mobile Vendor permit that corresponds
14 with the Mobile Vendor's business activity while Vending in accordance with this Article 2A.

15 **SEC. 2A.3. MOBILE VENDOR PERMIT TYPE.**

16 (a) Each Mobile Vendor permit must identify whether the permit authorizes the permittee to
17 Vend Food, Vend Merchandise, or Vend both Food and Merchandise.

18 (b) The Department may issue a time-limited Mobile Vendor permit to a nonprofit
19 corporation that is exempt from federal taxation under 26 U.S.C. section 501(c)(3), as it may be
20 amended, and which permit may apply to multiple Mobile Vendors as further described in the permit.

21 **SEC. 2A.4. PERMIT APPLICATION; FEE.**

22 (a) **Department Permit.** The Department shall establish a uniform application process
23 through which a Mobile Vendor may request, and upon approval receive, a Mobile Vendor permit. The
24 permit application shall require:

25 (1) The name, phone number, and current mailing address of the Mobile Vendor.

1 (2) A description of the Food and/or Merchandise to Vend.

2 (3) A certification by the Mobile Vendor that to their knowledge and belief, the
3 information submitted for the permit application is true.

4 (4) Proof of Identity, as described in Administrative Code Section 95.2 and as it may
5 be amended, of the Mobile Vendor.

6 (5) The California seller's permit number (California Department of Tax and Fee
7 Administration sales tax number), if applicable, of the Mobile Vendor.

8 (6) If the Mobile Vendor is an agent of an individual, company, partnership, or
9 corporation (each a "principal"), the name and business address of the principal.

10 (7) Any other information deemed relevant by the Department.

11 **(b) Additional Permit Conditions.**

12 (1) Each Mobile Vendor shall register with the Tax Collector pursuant to Article 12
13 (Business Registration) of the Business and Tax Regulations Code, if applicable. Separate fees may
14 apply and be payable to the Tax Collector.

15 (2) Each permit that applies to a Mobile Vendor that uses an energy source,
16 including propane, butane, or battery, is conditioned on the Mobile Vendor obtaining approval from
17 the Port Fire Marshal and complying with sections of the Fire Code that apply to the use of flammable
18 gas, flammable liquids, compressed gas, open flames, and other energy sources. Separate fees may
19 apply and be payable to the Port Fire Marshal.

20 (3) Each permit for Food Vending is conditioned on the Mobile Vendor obtaining a
21 permit to operate a food facility from the Department of Public Health pursuant to Health Code Section
22 452, as it may be amended. Separate fees may apply and be payable to the Department of Public
23 Health.

24 (4) Each Mobile Vendor permit issued pursuant to this Article 2A and the approval,
25 as applicable, of the Tax Collector (issuance of business registration certificate; see subsection (b)(1)),

1 Port Fire Marshal (see subsection (b)(2)), and the Department of Public Health (see subsection (b)(3)),
2 shall authorize inspection by the City of the Mobile Vendor's operations at any time during operating
3 hours.

4 (5) The applicable conditions of this subsection (b) are preconditions to the issuance
5 of a Mobile Vendor permit. Lapse or revocation of approvals, as applicable, from the Tax Collector,
6 Port Fire Marshal, or Department of Public Health shall, by operation of law, automatically invalidate
7 any Mobile Vendor permit without further action by the Department.

8 (c) **Permit Fee.** The Department shall identify the reasonable regulatory costs for the
9 administrative enforcement and any adjudication of this Article 2A, including but not limited to the
10 Department's costs to issue permits, perform investigations, conduct inspections, issue administrative
11 citations or other enforcement actions, and audit permittees. The Department shall charge applicants
12 for each Mobile Vendor permit and permit renewal an amount that does not exceed the reasonable
13 regulatory costs described in this subsection (c), and may include the actual costs that other agencies,
14 boards, commissions, or departments of the City incur in connection with the processing or
15 administration of this Article 2A, which fee shall be waived in accordance with California Business and
16 Professions Code section 16102, as it may be amended, and as applicable. The fee set forth in this
17 subsection (c) shall be approved by the Port Commission and may be adjusted each year, without
18 further action by the Board of Supervisors. In addition, separate annual fees may apply and be payable
19 to the Tax Collector, Department of Public Health, and the Port Fire Marshal for any approvals
20 required by each department.

21 (d) **Permit Expiration.** Each Mobile Vendor permit shall expire one year after issuance by
22 the Department unless renewed or unless the particular circumstances warrant a permit term of less
23 than one year.

24 (e) **Permit Renewal.**

1 (1) Each Mobile Vendor permit may be renewed annually so long as the Mobile
2 Vendor remains in compliance with this Article 2A, including payment of all fees due to the City and
3 compliance with the Good Neighbor Policies.

4 (2) Each Mobile Vendor permit renewed by the Department is not operative unless
5 and until the Mobile Vendor has within 30 days of the date of renewal obtained approvals, as
6 applicable, from the Port Fire Marshal and the Department of Public Health.

7 **(f) Application Denial; Appeal.**

8 (1) The Department may reject an application for Mobile Vendor permit for any of
9 the following reasons: (A) the applicant failed to provide any required information or prerequisite
10 approvals identified in this Section 2A.4, or provided incorrect or incomplete information, and failed to
11 correct the application within a reasonable time identified by the Department; (B) the applicant
12 knowingly presented false and material information or knowingly omitted material information; (C) the
13 applicant previously received a permit, which permit was revoked pursuant to Section 2A.8, and the
14 revocation occurred within one year of the application; (D) the applicant submitted a substantially
15 similar application that was rejected within the past year; or (E) good cause, including but not limited
16 to violations of federal, state, or City law that in the Department’s judgment are relevant to whether the
17 applicant would perform as a Mobile Vendor in a lawful manner.

18 (2) The rejection of an application for a Mobile Vendor permit may be appealed in
19 writing to the Director within 10 days of rejection. The Director may investigate the rejection and
20 consider any claims by the applicant, and shall either affirm or reverse the rejection within 30 days of
21 receipt of the written appeal.

22 **SEC. 2A.5. VENDING RESTRICTIONS; DELEGATION OF AUTHORITY.**

23 (a) Certified Farmer’s Market or Swap Meet. No person, without written approval of the
24 Director, may Vend within the immediate vicinity of a permitted Certified Farmers’ Market or a
25 permitted Swap Meet during the operating hours of that Certified Farmers’ Market or Swap Meet.

1 **(b) Temporary Special Permit.** *No person, without written approval of the Director, may*
2 *Vend within the immediate vicinity of a temporary special permit issued by the City, or any of its*
3 *departments or agencies, that authorizes the temporary use of, or encroachment on, the sidewalk or*
4 *other public area, including an encroachment permit, special event permit, or temporary event permit*
5 *for purposes including filming, parades, or outdoor concerts. This prohibition against Vending shall*
6 *be effective only for the limited duration of the temporary special permit. Any notice, business*
7 *interruption mitigation, or other rights provided to affected businesses or property owners under the*
8 *temporary special permit must also be provided to any Mobile Vendor specifically permitted by the*
9 *Director to operate in the immediate vicinity of the temporary special permit.*

10 **(c) Rules and Regulations Authorized.**

11 **(1)** *The Department, and any other agency (including but not limited to a*
12 *department or commission) of the City that governs the use of public property (including but not limited*
13 *to the Port Commission and its Executive Director), may adopt additional requirements regulating the*
14 *time, place, and manner of Vending if the requirements are directly related to objective health, safety,*
15 *or welfare concerns. Such Rules and Regulations may impose, but are not limited to imposing, (A)*
16 *further requirements to maintain sanitary conditions; or (B) requirements necessary to ensure*
17 *compliance with the Americans with Disabilities Act of 1990 (Public Law 101-336), as amended, and*
18 *other disability access standards.*

19 **(2)** *The Department, and any other agency (including but not limited to a*
20 *department or commission) of the City that governs the use of public property (including but not limited*
21 *to the Port Commission and its Executive Director) may prohibit Stationary Mobile Vendors from*
22 *Vending in a park if the operator of the park has signed an agreement for concessions that exclusively*
23 *permits Vending of Food, Merchandise, or both by one or more concessionaires.*

24 **(3)** *The Department, and any other agency (including but not limited to a*
25 *department or commission) of the City that governs the use of public property (including but not limited*

1 to the Port Commission and its Executive Director), may adopt additional requirements regulating the
2 time, place, and manner of Vending in one or more parks if the requirements are: (A) directly related to
3 objective health, safety, or welfare concerns; or (B) necessary to ensure the public's use and enjoyment
4 of natural resources and recreational opportunities; or (C) necessary to prevent an undue
5 concentration of commercial activity that unreasonably interferes with the scenic and natural character
6 of the park.

7 **SEC. 2A.6. EXEMPTIONS.**

8 This Article 2A does not govern:

9 (a) the sale of an art or craft regulated under Article 24 (Regulating Street Artists) of the
10 Police Code; or

11 (b) the operation of, or any sale within, a Certified Farmers' Market; or

12 (c) the operation of, or any sale within, a permitted Swap Meet.

13 **SEC. 2A.7. GOOD NEIGHBOR POLICIES.**

14 Mobile Vendors shall operate in accordance with the following good neighbor policies:

15 (a) Mobile Vendors shall be individually responsible for any garbage, detritus, or debris
16 that directly results from their Vending activity;

17 (b) Noise and odors shall be contained within the immediate area of the Mobile Vendor so
18 as not to be a nuisance to neighbors; and

19 (c) Mobile Vendors shall urge patrons to not litter and to maintain the safety, cleanliness,
20 quiet, peace, and orderliness of the area; and

21 (d) Stationary Mobile Vendors shall provide for proper and adequate storage and disposal
22 of garbage, detritus, and debris.

23 **SEC. 2A.8. ENFORCEMENT.**

24 (a) Nuisance Declaration. Any violation of this Article 2A, or any applicable Rules and
25 Regulations, constitutes a public nuisance.

1 **(b) Administrative Citation.** Any Enforcement Official may issue an Administrative
2 Citation as described below for any violation of this Article 2A, or of the Rules and Regulations that
3 interpret and implement this Article, that occurs on a public right-of-way (as that term is defined in
4 Public Works Code Section 2.4.4) or any other street, sidewalk, alley, walkway, wharf, pier, or
5 pedestrian path available to the public:

6 (1) Vending that violates a requirement in this Article or in the Rules and
7 Regulations, other than failure to possess a valid license or permit:

8 (A) An administrative fine equal to \$100 for a first violation.

9 (B) An administrative fine equal to \$200 for a second violation within twelve
10 months of the first violation.

11 (C) An administrative fine equal to \$500 for a third violation, and each
12 subsequent violation, within twelve months of the first violation.

13 (D) In addition to any other authorized enforcement activity, a Mobile Vendor's
14 license and/or permit may be revoked or suspended for the remainder of its term upon a fourth or
15 subsequent violation.

16 (2) Vending without a valid license or permit:

17 (A) An administrative fine equal to \$250 for a first violation.

18 (B) An administrative fine equal to \$500 for a second violation within twelve
19 months of the first violation.

20 (C) An administrative fine equal to \$1,000 for a third violation, and each
21 subsequent violation, within twelve months of the first violation.

22 (D) Upon submission of proof of a valid permit, the administrative fines set forth
23 in subsections (A) through (C) of this subsection (b)(2) shall be reduced to equal the administrative
24 fin es set forth in subsections (A) through (C) of subsection (b)(1), as those amounts may be revised
25 pursuant to subsection (b)(5).

1 (3) Failure to pay an Administrative Citation described in this subsection (b) shall
2 not be punishable as an infraction or misdemeanor; further, additional fines, fees, assessments, or any
3 other financial conditions beyond those authorized in this subsection (b) may not be assessed.

4 (4) When assessing an Administrative Citation authorized in this subsection (b), the
5 Director shall take into consideration the person's ability to pay the fine using the criteria described in
6 subsection (a) or (b) of California Government Code section 68632, as it may be amended. Notice
7 shall be given to the Mobile Vendor of the right to request an ability-to-pay determination and
8 instructions or other materials for requesting an ability-to-pay determination. The person may request
9 an ability-to-pay determination at adjudication or while the judgment remains unpaid, including when
10 a case is delinquent or has been referred to a comprehensive collection program. If the Mobile Vendor
11 meets the ability-to-pay criteria, the Department shall accept 20% of the total administrative fine
12 specified in subsection (b)(1) or (b)(2), as applicable, as full satisfaction.

13 (5) The amounts of the administrative fines identified in subsections (A) through (C)
14 of subsections (b)(1) and (b)(2) shall automatically increase or decrease to the maximum amount
15 authorized under California Government Code section 51039, as it may be amended. If section 51039
16 is repealed and not replaced with a similar limitation on administrative fines, then the administrative
17 fine amounts in this Section 2A.8 may be adjusted each year, without further action by the Board of
18 Supervisors, to reflect changes in the relevant Consumer Price Index.

19 (6) Within 10 days of issuance, the Administrative Citation must be paid unless a
20 written appeal is filed with the Director. The grounds of appeal are limited to error or abuse of
21 discretion in the issuance of the Administrative Citation. The Director may make an ability-to-pay
22 determination pursuant to subsection (b)(4), but inability to pay shall not be grounds for rescinding the
23 Administrative Citation or reducing the amount required to satisfy the fine to an amount less than the
24 amount specified in subsection (b)(4). The Director may investigate the Administrative Citation and
25 any claims by the appellant, and shall issue and mail a written decision on the appeal within 30 days of

1 receipt of the written appeal. Within 20 days of the Director's decision upholding a fine in whole or in
2 part, the Administrative Citation must be paid. The method for judicial review of an Administrative
3 Citation pursuant to subsection (b)(1) is an appeal filed with San Francisco Superior Court pursuant to
4 Government Code section 53069.4.

5 (7) Collection of Fines. The failure of any person to pay a fine assessed by
6 administrative citation within the required time constitutes a debt to the City. Simple interest at 10%
7 per year shall accrue on unpaid amounts. The City may file a civil action including a small claims
8 action or may pursue any other legal remedy to collect such money.

9 (c) **Temporary Order to Cease Vending and Removal.**

10 (1) Any Enforcement Official may order a Mobile Vendor to promptly cease Vending
11 when, in the judgment of the Enforcement Official, (A) the Mobile Vendor constitutes a safety hazard,
12 including but not limited to impeding the safe use of a public right of way by pedestrians and persons
13 with disabilities, or (B) when the presence of an emergency so requires, or (C) if the Mobile Vendor is
14 unpermitted.

15 (2) (A) After the Enforcement Official orders an unpermitted Mobile Vendor to
16 cease Vending, the Mobile Vendor must discontinue any Vending and remove all Food, Merchandise,
17 and any other Vending paraphernalia from property within the regulatory jurisdiction of the Port. A
18 failure to promptly obey any such orders from an Enforcement Official is a violation of this Article 2A

19 (B) After the Enforcement Official orders a permitted Mobile Vendor to cease
20 Vending, the Mobile Vendor must discontinue any Vending and follow the orders of the Enforcement
21 Official with regard to removing and relocating all Food, Merchandise, and any other Vending
22 paraphernalia, and any other orders the Enforcement Official may give to mitigate safety hazards, and
23 no further Vending may occur until the conditions that caused the order to cease Vending have been
24 abated to the satisfaction of the Enforcement Official. A failure to promptly obey any such orders from
25 an Enforcement Official is a violation of this Article 2A.

1 (3) If a Mobile Vendor fails, within a reasonable time, to remove Food, or
2 Merchandise, or any other Vending paraphernalia from the location subject to the order to cease
3 Vending, or to follow any other orders the Enforcement Official may issue to mitigate safety hazards,
4 the Enforcement Official may order the Department to remove any or all of the items. Prior to removal
5 by the Department, the Enforcement Official shall warn the Mobile Vendor of the impending removal
6 and impoundment, and shall urge the Mobile Vendor to make every effort to remove the items, or cause
7 their removal. Where the Department actually removes any items, the Enforcement Official shall issue
8 an Administrative Citation to the Mobile Vendor. The Mobile Vendor shall pay the actual costs of
9 removal and storage of any items impounded, and of disposal of any items the storage of which may
10 cause public health, safety, or infestation issues. The Mobile Vendor may contest the liability for these
11 costs by timely appealing the Administrative Citation. However, these actual costs to the City are not
12 subject to reduction based on the ability to pay; actual costs are a debt to the City that may be collected
13 in the same manner as provided in subsection (b)(7). Mobile Vendor items that have been removed and
14 stored may be recovered within 90 days from the date of removal and upon payment of a sum equal to
15 the costs of removal, plus any reasonable transport and storage costs, as determined by the
16 Department, and any costs incurred by the Department in disposing of any items contained in the
17 Mobile Food Facility.

18 (d) **Other Violations.** Any violation of this Article 2A, or of the Rules and Regulations that
19 interpret and implement this Article, that occurs on either: any area open to the public on private
20 property, or on public property other than a Public right-of-way (as that term is defined in Public
21 Works Code section 2.4.4) or any other street, sidewalk, alley, walkway or pedestrian path available to
22 the public, may be subject to one or more of the following:

23 (1) An administrative fine as described in subsection (b).

24 (2) Civil Action.

1 (A) The Department may refer violations to the City Attorney to maintain an
2 action for injunction to restrain to cause the correction or abatement of the violation of this Article 2A,
3 and for recovery of any City department’s enforcement and abatement costs (including but not limited
4 to costs for removal, storage, impoundment, and disposal).

5 (B) The City shall be awarded its reasonable attorney’s fees and costs incurred
6 in enforcing this Article 2A.

7 **SEC. 2A.9. EXTORTION.**

8 Any extortion of a Mobile Vendor (including but not limited to extortion by a person or entity
9 who employs or facilitates Vending by the Mobile Vendor, a member of the public, or an Enforcement
10 Official), will be punishable under Section 518 of the California Penal Code and any attempted
11 extortion of a Mobile Vendor will be punishable under Section 524 of the California Penal Code.

12 **SEC. 2A.10. REPORTING REQUIRED.**

13 The Department, in consultation with the Department of Public Health, shall report to the
14 Board of Supervisors regarding the implementation of this Article 2A and any health and safety
15 enforcement actions related to Mobile Food Vendors: six months after the effective date of Article 2A;
16 annually for the first three years after the effective date of Article 2A; and once every three years
17 thereafter (see Health Code Section 452.2 (Reporting Required)).

18 **SEC. 2A.11. UNDERTAKING FOR THE GENERAL WELFARE.**

19 In enacting and implementing this Article 2A, the City is assuming an undertaking only to
20 promote the general welfare. It is not assuming, nor is it imposing on its officers and employees, an
21 obligation for breach of which it is liable in money damages to any person who claims that such breach
22 proximately caused injury.

23 **SEC. 2A.12. SEVERABILITY.**

24 If any section, subsection, sentence, clause, phrase, or word of this Article 2A, or any
25 application thereof to any person or circumstance, is held to be invalid or unconstitutional by a

1 decision of a court of competent jurisdiction, such decision shall not affect the validity of the remaining
2 portions or applications of the Article. The Board of Supervisors hereby declares that it would have
3 passed this Article 2A and each and every section, subsection, sentence, clause, phrase, and word not
4 declared invalid or unconstitutional without regard to whether any other portion of the Article or
5 application thereof would be subsequently declared invalid or unconstitutional.

[Various Codes - Mobile Vendor Regulation]

Ordinance adopting regulation of vending within the jurisdiction of the Port of San Francisco, requiring permits, and authorizing permit fee and enforcement actions in the Port Code; requiring the Port and the Department of Public Health to report to the Board of Supervisors about regulatory implementation and health and safety enforcement; amending provisions of the Port and Public Works Codes, and repealing peddler regulations in the Police Code, to comply with state law regarding sidewalk vending; amending provisions of the Administrative, Business and Tax Regulations, Health, and Transportation Codes to conform with state law and new Port Code regulations regarding vending; and adopting findings under the California Environmental Quality Act.

Existing Law

Police Code Sections 864 through 870 regulate “peddlers,” requiring permits and authorizing police enforcement via criminal infractions and misdemeanors. Public Works Code Article 5.8 (Sections 184.80 *et seq.*) establishes the Department of Public Works’ regulatory program for mobile food facilities, including regulation of pushcarts. Senate Bill (SB) 946 (effective January 1, 2019) constrains local regulation of the time, place, and manner of sidewalk and street vending, and also prohibits criminal penalties to enforce local regulations.

Amendments to Current Law

The Ordinance would repeal all peddler regulations in the Police Code and create a new regulatory program in the Port Code for street and sidewalk vendors (“mobile vendors”) vending within the jurisdiction of the Port of San Francisco that would require permits to vend food, merchandise, or both; authorize a permit fee, rules and regulations to govern the time, place, and manner of vending, and enforcement methods including administrative citations and impoundment. The Ordinance would regulate mobile vendors of food, merchandise, or both. The Ordinance would not alter food safety regulations or revise Public Works Code Article 5.8, but requires the Port and Department of Public Health to report to the Board of Supervisors regarding enforcement and implementation. The Ordinance includes technical amendments to the Administrative, Business and Tax Regulations, Health, Port, Police, and Transportation Codes to conform with the repeal of peddler regulations in the Police Code.

Background Information

Police Code peddler regulations have not been enforced since the effective date of SB 946 (January 1, 2019).

I am a resident of San Francisco and own a business here and am writing to encourage you to support Supervisor Peskin's proposed ordinance regulating mobile vending in Fisherman's Wharf. My family and I visited Pier 39 and the Wharf recently and we were shocked at the number of street vendors that have taken up residence around Pier 39 and between Pier 41 and Pier 45. To be honest, my wife and two sons did not feel entirely safe nor did we enjoy the experience of having items hawked and the sidewalks taken up by unlicensed vendors. It changes how you experience one of the landmarks of our city and makes me unlikely to return. I am saddened to not enjoy sharing what was an amazing childhood memory for me with my kids.

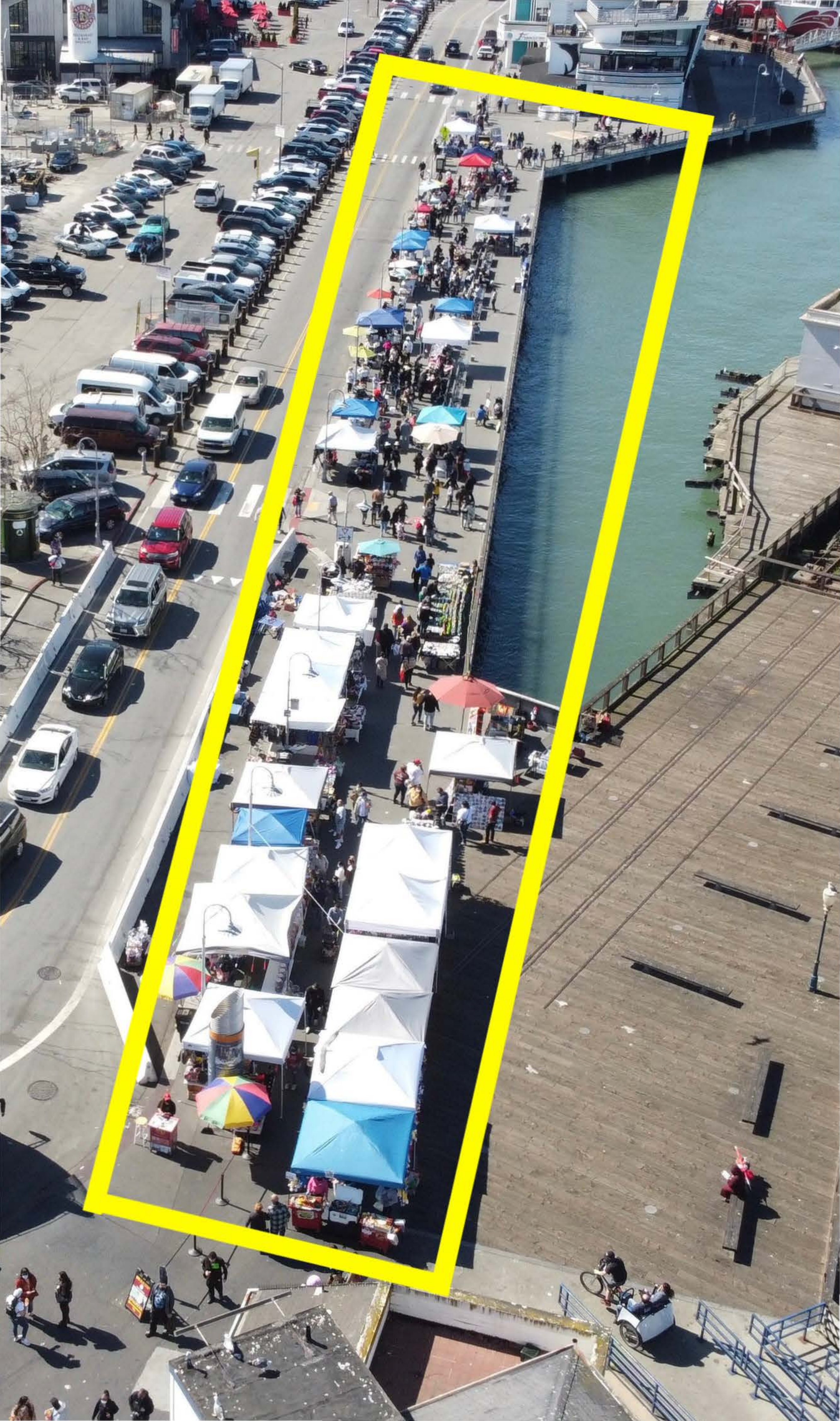
We have friends who work at Pier 39 and have been told that the unlicensed vending problem has increased throughout the state due to the passage of SB 946. But we were unprepared for the hundred or so unlicensed vendors at the gigantic flea market that has sprung-up without any facilities for handwashing or refrigeration of perishable foods, that uses propane tanks and open flame cooking on the sidewalks, that sells alcoholic beverages without any ID check, and displays table after table of counterfeit merchandise. These are not local artisans working to get a leg-up by peddling their wares. This is organized, pernicious illegal activity that the city has allowed to fester and become a health risk and an eyesore for visitors coming to San Francisco.

My family loves to visit the Wharf and Pier 39 and enjoys its vibrancy and many fun activities. As a business owner, I am keenly aware of the area's importance as

a visitor hub and economic engine for the general fund. I want to express my support for regulating the many unhealthy and unlawful activities that are taking place at Pier 39 and the Wharf. What's been allowed to take root in District 3 is shocking and disappointing, and the proposed pilot program is a great first-step to control the problem. The city should do everything it can to protect its hard-earned reputation as a world-class visitor destination, especially now as the area's businesses are struggling to survive and recover.



If this legislation passes, Port Code, Article 2A, will establish a new regulatory program for street and sidewalk vendors who will be required to pay a permit fee to vend food, merchandise, or both. The Port Department shall identify the reasonable regulatory costs for the administrative enforcement and any adjudication, including but not limited to the costs to issue the permit, perform investigations, conduct inspections, issue administrative citations or other enforcement actions, and audit permittees. The Port Department shall charge applicants for each Mobile Vender permit and permit renewal, an amount not to exceed the reasonable amount determined and approved by the Port Commission. Separate fees may be applied by the Tax Collector under the Business and Tax Regulations Code, Article 12, and the Department of Public Health under Health Code, Section 452; in addition, separate annual

fees may apply and be payable to the Tax Collector, Department of Public Health, and the Port Fire Marshal for any approvals required by each department. The fees due may include the actual costs that other agencies, boards, commissions, or departments of the City incur in connection with the processing or administration of Port Code, Article 2A; which fee shall be waived in accordance with California Business and Professions Code, Section 16102, as it may be amended, and as applicable. The fee set forth in Port Code, Section subsection (c) shall be approved by the Port Commission and may be adjusted each year, without further action by the Board of Supervisors. On March 17, 2020, the Board of Supervisors authorized their Board and Committee meetings to convene remotely and allow for remote public comment.
