3 **Resolution approving the Fiscal Years (FYs) 2026-2027 and 2027-2028 Expenditure Plan**
4 **for the Department of Homelessness and Supportive Housing Fund.**

6 WHEREAS, Administrative Code, Section 10.100-77, established the Homelessness
7 and Supportive Housing Fund for the purpose of providing housing, utilities, meals, and other
8 services for formerly homeless County Adult Assistance Program ("CAAP") recipients; and

9 WHEREAS, If planned annual expenditures from the Homelessness and Supportive
10 Housing Fund exceed \$11,900,000, Administrative Code, Section 10.100-77(f) requires the
11 Department of Homelessness and Supportive Housing ("HSH") to submit to the Board of
12 Supervisors a plan explaining how the Department intends to spend the money; and

13 WHEREAS, The Administrative Code requires the Board of Supervisors to approve the
14 expenditure plan by Resolution before adopting the Ordinance appropriating funds for these
15 expenditures; and

16 WHEREAS, The FYs 2026-2027 and 2027-2028 budgets for the HSH include
17 proposed expenditures from the Homelessness and Supportive Housing Fund in excess of
18 \$11,900,000; and

19 WHEREAS, HSH has submitted to the Board of Supervisors the FYs 2026-2027 and
20 2027-2028 expenditure plan for the Homelessness and Supportive Housing Fund; now,
21 therefore, be it

22 RESOLVED, That the Board of Supervisors hereby approves the FYs 2026-2027 and
23 2027-2028 expenditure plan for the Homelessness and Supportive Housing Fund as
24 submitted by the HSH pursuant to Administrative Code, Section 10.100-77(f).



Homelessness and Supportive Housing Fund (Housing First Program) FY2026-2027 and FY2027-2028 Expenditure Plan

This expenditure plan for the Homelessness and Supportive Housing (HSH) Fund for FY2026-27 and FY2027-28 is submitted to the Board of Supervisors pursuant to Section 10-100.77(f) of the San Francisco Administrative Code. The Administrative Code requires the Department of Homelessness and Supportive Housing to submit this expenditure plan if annual proposed appropriations from the Homelessness and Supportive Housing (HSH) Fund exceed \$11.9 million. This plan must include estimates of the amounts to be spent for various purposes, as well as an explanation of who is to benefit from these expenditures, how many people will benefit, and how the proposed benefits will be provided.

Planned Expenditures: The budget for the Department of Homelessness and Supportive Housing includes proposed expenditures from the Homelessness and Supportive Housing Fund of \$23,115,564 in FY26-27 and \$23,445,130 in FY27-28 (see Attachment). The proposed expenditures are divided into two general categories: housing and services. The proposed FY26-27 expenditures are supported by \$23,115,564 in projected FY26-27 HSH Fund revenues and \$8,275,849 in projected FY26-27 General Fund revenues. The proposed FY27-28 expenditures are supported by \$23,445,130 in projected FY27-28 HSH Fund revenues and \$8,882,025 in projected FY27-28 General Fund revenues.

Beneficiaries: The Housing First Program is funded by the Homelessness and Supportive Housing (HSH) Fund. The beneficiaries of the proposed spending under this plan are homeless and formerly homeless County Adult Assistance Programs (CAAP) clients of the Department of Human Services. HSH estimates that approximately 1,267 units will be made available to CAAP clients through this proposed spending plan. Since the beginning of the Housing First Program in May 2004, a total of 6,427 homeless and formerly homeless CAAP clients have been placed into Permanent Supportive Housing (data through April 30, 2026).

How Benefits Are Provided: Access to the Housing First Program is provided to any CAAP client listed as being homeless with their assigned CAAP worker. CAAP clients experiencing homelessness are referred to Adult Coordinated Entry Access Points to be assessed and prioritized for housing referral based on various criteria, such as levels of vulnerability, length and history of homelessness, and severity of housing barriers. Until a housing placement is made, shelter is offered by the CAAP worker for the time between monthly homeless verification appointments. Each time the CAAP clients experiencing homelessness see their eligibility worker for a monthly homeless verification appointment, their worker checks to see if housing is available and if so, will offer an opportunity to apply for housing. Additional outreach is done to CAAP clients experiencing homelessness who have been utilizing shelter for long periods. As housing opportunities are available, CAAP clients experiencing homelessness are referred to HSH Coordinated Entry staff that provide support through the screening and placement process. When a CAAP client is placed in housing, HSH staff makes arrangements with the CAAP worker for benefits to be adjusted and routed correctly and notifies both the CAAP and CalFresh Division of the Human Services Agency of the client's new address.

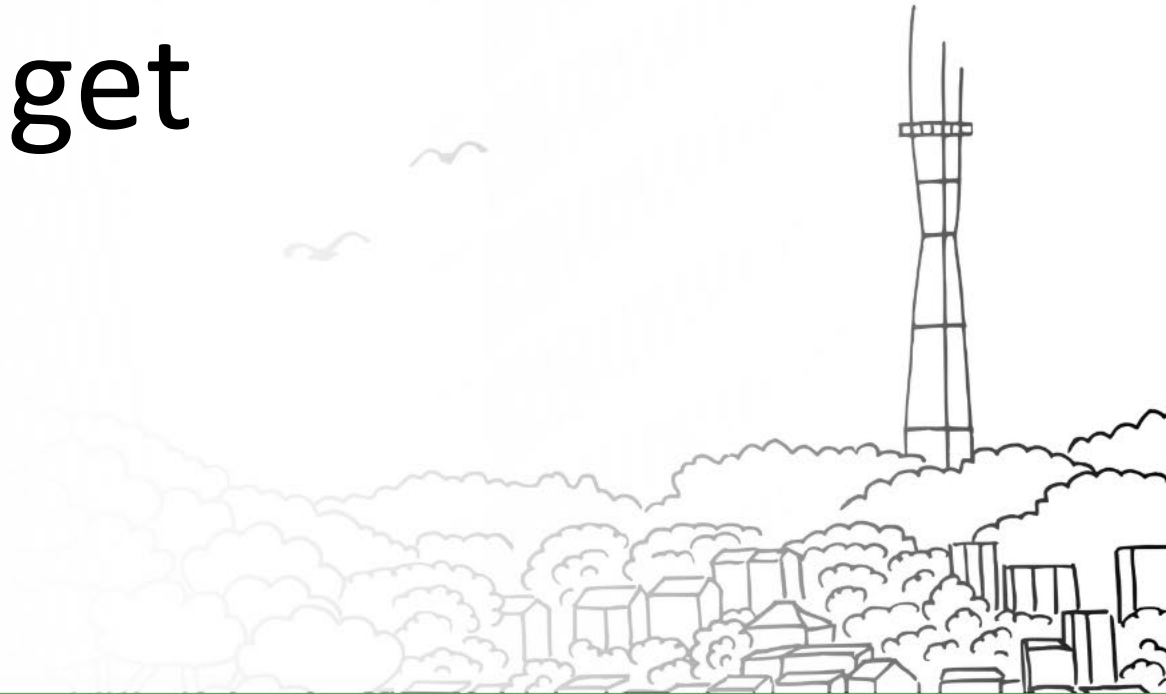

HSH Fund: Trailing Legislation

- Administrative Code Sec. 10-100.77(f) requires the Department to submit an **expenditure plan** if the proposed appropriations from the HSH Fund exceed \$11.8 million.
- The HSH fund supports formerly homeless recipients of the Human Service Agency's **County Adult Assistance Program (CAAP)**.
- Resolution approves the FY 2026-27 and FY2027-28 Expenditure Plans.

OCOH Fund: Trailing Legislation

- Temporarily lifts the OCOH **12% cap** on short-term rental subsidies for **FY 2027–2028**.
 - Allows more housing funds to support rapid rehousing, shallow subsidies, and temporary rental assistance.
 - Focuses on families, transitional-age youth, and adults.
 - Maintains existing OCOH funding categories and does not change future allocation percentages.
 - Builds on prior temporary cap lifts approved for previous fiscal years, through FY 2026-2027.
